

Public Meeting

Cedar Springs School House, Dallas Co., Texas, April 29, 1861

In accordance with previous notice the citizens in the vicinity of Cedar Springs met in convention at the Cedar Springs School Mouse to consult with each other upon the best ways and means by which to secure peace and happiness to their families and also to protect themselves from macrassion of the North.

On motion the Rev. James A. Smith was appointed Chairman of the meeting and John H. Cochran. Secretary.

The Chairman opened the Convention with prayer, invoking the aid of the God of nations in our behalf. After prayer the Chairman was called upon to explain the objects of the meeting, which he did in a very eloquet and forcible manner.

On motion Col. George W. Record, Judge John Thomas, O. W. Knight, and W. R. Smith were appointed a committee to draft resolutions expressive of the sense of the meeting.

On Motion of Col. G. W. Record, the Chairman was added to the Com-

The Committee reported the following preamble and resolutions which were adopted to wit:

WHEREAS - information received from various sources, we have reanot apprehend the invasion of our soil by a hostile and armed force;
and whereas it is the duty and privilege of good citizens to unite for
the protection of our common country, and especially of our firesides
and homes against invasion, insult, and indury, therefore;

RESOLVED 1st - That we will use our best efforts to organize an independent company of volunteers to be called "Dallas Home Guards, Company A" subject to such rules and regulations as may be adopted by said company when organized;

RESOLVED 2nd - That we recommend to the people of Dallas County to hold similiar meetings in every precinct or populous neighborhood in the county:

RESOLVED 3rd - That the surplus revenue in the Treasury of Dallas County should be appropriated by the County Court for the purpose of purchasing arms for the use of such companies as may be organized in the

county for the protection of our homes and contiguous frontier:

RESOLVED 49 - That the Hon. J. M. Patterson be and is hereby memoralized and requested to call the County Court to take this subject into consideration at an early data.

SOURCES OF REVOLUTIONARY SERVICE RECORDS

MASSACHUSETTS: Massachusetts Soldiers and Sailors of the Revolution. The Journals of the Provincial Congress. Massachusetts Town Officials, 1775-1783. (The last named is a five-volume set of typewritten records at the D.A.R. Library and is one of the many contributions of their Geneslogical Records Committee. It lists town officials during the Revolutionary period for about one hundred and thirty towns, which means patriotic service for many hundreds of Massachusetts ancestore.)

There are also the printed vital records for many Massachusetts towns which are invaluable in proving marriages and lines of descent.

In connection with Massachusetts should be mentioned: Revolutionary Soldiers of Maine (published by Maine Sons of the Revolution). Journal of Maine History --- Vols. 5-8 by Sprague.

COMMECTICUT: Connecticut Men in the Revolution (published by the State of Connecticut). Collections of the Connecticut Historical Society, Vols. 8 and 12 (these are known as Revolutionary Rolls and Lists). Public Records of the Colony of Connecticut. Public Records of the State of Connecticut.

The vital records of a few Connecticut towns have been printed, and there are numerous county and town histories which give muster rolls, militia lists, and accounts of Revolutionary soldiers, and are a good source for family data and proof of lines. RHODE ISLAND: Spirit of '76 by Cowell (Index to this work is found in Vol. 12 of Arnold's Vital Statistics). Civil and Military Lists of Rhode Island. Defenses of Rhode Island.

NEW YORK: New York in the Revolution as Colony and State--- Vol. 1, and Supplement---Vol. 2 by James A. Roberts. New York State Archives--- Vol. 1, edited by Berthold Fernow. Calendar of Historical Menuscripts relating to the War of the Revolution in the Office of the Secretary of State, Albany---2 vols. (cited as New York Colonial Manuscripts---Revolutionary Papers). Balloting Book and Other Documents Relating to Military Bounty Lands in the State of New York. George Clinton Papers---10 vols. Refugees of 1776 from Long Island to Connecticut---Mather.

A valuable collection of typewritten genealogical records, ll vols., compiled by the Genealogical Records Committee, is found at the D.A.R. Library, and is titled Graves of Revolutionary Soldiers and Their Wives.

Where proof cannot be found elsewhere, application for information may be made to the Manuscripts and History Section of the New York State Library, Albany.

NEW JEESEY: Official Registor of the Officers and Men of New Jorsey in the Revolutionary War---Stryker. Minutes of the Frovincial Congress and the Council of Safety. The Correspondence of the Executive of New Jersey, 1775 to 1786. Newspaper Extracts---Vols. 1-5 (New Jersey Archives, 2nd Series)

Supplementing these printed works, the D.A.R. Library has a number of volumes of unpublished genealogical records with Revolutionary material. Of particular value is a set of eight volumes---Revolutionary Soldiers of New Jersey.

PENNSYLVANIA: The Revolutionary records of Pennsylvania's soldiers are to be found virtually complete in: Pennsylvania Archives---Fifth Series.--Pennsylvania Archives---Sixth Series---Vol. I and II.

A few records not found in the Fifth and Sixth Series are printed in the Second and Third Series. If service is not included in one of the above, the Archives Division of the State Library, Harrisburg, may be able to furnish it, especially if exact location as to county and township are given.

Pennsylvania German Pioneers (3 vols.) is helpful in giving location of early settlers.

DELAWARE: Delaware Archives -- Vols. I, II, and III. Index to the Oaths of Allegiance in State Archives. Governors Register, 1674-1851.

Where service cannot be established from other sources the State Archives at Dover have many church and tombstone records, as well as early vital statistics.
