Barbara Roberts Baylis is a third-generation Texan, born in Longview, Texas, and a thirty-year resident of the Lake Highlands area of Dallas. She began her genealogical research in 1970 by attending a course at El Centro College. She has attended the National Genealogical Conferences in Biloxi, Mississippi, and Raleigh, North Carolina, and the Federation of Genealogical Societies Conference in Boston, Massachusetts. She has researched extensively in New England as well as Washington, D. C., Virginia, the Carolinas, Georgia, Mississippi, England and Wales. She is a member of seven lineage societies, a number of family associations and genealogical societies. For the past three years she has served as a member of the Board of Directors of the Dallas Genealogical Society and is presently serving as Regent for the James Billingsley Chapter, Daughters of the American Revolution.

Patricia Law Hatcher has done genealogical research since 1982 and joined the Dallas Genealogical Society in 1983. A member of several genealogical and hereditary societies, she is an organizing officer of the Richard Bard Chapter of the National Society Daughters of the American Revolution, a charter member of the National Society Descendants of Early Quakers and a member of the National Society of New England Women. She recently published a four-volume set entitled Abstracts of Graves of Revolutionary Patriots, through her own genealogical publishing company, Pioneer Heritage Press.

An index of the names of the 4,500+ persons buried in the Mount Holly Cemetery in Little Rock, Arkansas is being compiled to be published as part of the cemetery's sesquicentennial celebration in 1993. Descendants are invited to submit information concerning any ancestor known to be buried there. Often called the Westminster Abbey of Arkansas because of the number of notables who have Mount Holly as their final resting place, it includes quite as many whose names are less well-known but played their equally important part in making Arkansas history. The book is being sponsored by the Mount Holly Cemetery Association. Social Security Administration Applications show the address of the applicant, date and place of birth, father's name and mother's maiden name. To obtain a copy of the application form for a deceased relative for Social Security, complete Form F SSA-L997, available from any S. S. A. office.

The S.S.A. plans to destroy the original 37 million applications for Social Security. They have computerized some of the information, but much of the general information has been omitted. This information will be lost when the original forms are destroyed. The early files include many persons born in the 1860's and 1870's and many naturalized citizens. It is suggested that letters be written to the Social Security Administration, 6401 Security Blvd., Baltimore, MD, 21235, and to your representatives in Congress for assistance in retaining these valuable records.

#### TEXAS RESEARCH NOTE

One of the most difficult parts of local research involves following the moves of pioneer families within Texas, particularly between census years. A little-known appendix to the 1860 Tarrant County tax schedules, located on microfilm in the Texas State Archives, may be of value to the researcher. The original handwritten rolls are extremely difficult to read, not because of the faded condition of the records but because of the hurried penmanship and poor spelling skills of the writer. The appendix, "Assessment of Lands, Situated in Other Counties, for 1860," lists the name of the property owner, a description of the real estate owned, the county in which it lies, and the amount of tax due.
