DGS Fall Symposium: A Success Story

Beautiful weather, an easily accessible location, interesting topics, and knowledgeable speakers all contributed to making the annual DGS Fall Symposium on 6 October the best yet. Held at the Preston Hollow Presbyterian Church, this year's symposium attracted 374 attendees from 37 cities in Texas and two from out of state. The packed classrooms, some with standing room only, made it apparent that the Fall Symposium was well-received by members and nonmembers alike.

Education is one of the main objectives of a genealogical society. With an eye toward meeting this objective, the symposium format, introduced by DGS three years ago, presented topics varying from research techniques such as land platting, to methodology, organization, photography, publishing, and the Genealogy Section in the Dallas Public Library. That there was something for everyone was shown by the number of people who repeated the statement, "I wish I could attend all the sessions!"

Equally appreciated was the well-attended beginners workshop, which introduced many new genealogists to proper research techniques. Beginners mixed with intermediate and advanced genealogists in the packed Fellowship Hall for "Let's Do Lunch," where people enjoyed the opportunity to renew friendships, make new ones, and exchange information on the topic posted on their table.

The Symposium Syllabus, prepared by Madilyn Crane, contained all the speakers' handouts. It was double the size of last year's Syllabus and the remaining few were quickly sold to nonattendees.

We follow up this month with another source that indexes periodicals, The Genealogical Periodical Annual Index (GPAI), on page 94. For instance, I found reliable information about a surname I research in Georgia in a California periodical by using one of these indexes. Check them out!

How to Clean a Tombstone Safely By Patricia Law Hatcher

When most of us see an ancestor's tombstone crusted over with lichen (that gray or green mosslike stuff), our first instinct is to scrub it off. While some preservationists believe the lichen should be left alone to protect the stone, others believe it can or should be removed safely. The key word is *safely*. No chemicals or metal tools should be used.

Begin by trimming away any brush, vines, weeds, and grass. Then use a cloth (old terry-cloth towels and washcloths are great) or a soft-bristled brush to remove loose dirt.

Now comes the most important ingredient: water, lots and lots of water. During last spring's record rainfalls, I wiped a badly encrusted stone clean easily with a washcloth. Saturate the lichen with water. It will soak up the water, so saturate it several more times. The lichen will soften until it practically slides off the stone with a squeegee,

Social Security Information

In response to an article published in the DGS Newsletter (Volume 14, January 1990, Issue 119), we have received the following letter dated 5 September from Vickie Higgins, Programs Specialist, Social Security Administration, Regional Office VI, Dallas, Texas:

"...I am providing information for your members who may want information about a deceased person from our records.

Generally, information about a deceased person is no longer protected under the Privacy Act. Therefore, if he or she applied for a Social Security number, we can provide a copy of the 'Application for Social Security Account Number' (Form SS-5) from our microfilm records. This document contains the person's name, date and place of birth, and parent's names which were given when he or she applied for the Social Security number.

Of course, the Social Security Administration did not begin keeping records until 1936; therefore, we have no records about people who died before then.

Although no particular form is necessary to request this information from our records, we do sometimes need certain identifying information in order to locate a specified record. Our records are filed by Social Security number, not by name. If a plastic scraper, terry-cloth rag, or soft-bristled brush. Wooden kitchen matches are great for cleaning out the letters. Caution: If a stone is splitting or flaking, be exceptionally careful and gentle when wiping the stone.

If you brought a can of shaving cream to help with photos, you can repeat the above steps with shaving cream and water.

As the final step, rinse the stone thoroughly. Now you have a clean, attractive stone to photograph or make a rubbing of. Tombstones seem to be deteriorating at an accelerating rate. In a few years your photograph or rubbing may be the only legible record of this stone.

So, next time you think you might be visiting a cemetery, take along some scrub rags, a soft brush, rubber squeegee, and as much water as you can carry (gallon milk jugs are great). Even when traveling by plane, I pack a plastic quart water bottle with rags inside and fill it with water at my motel or a service station.

Social Security number for the deceased person is provided, we will locate the record and provide a copy of the application on file. However, if the Social Security number is not provided, we will need the person's full name, date and place of birth, and parents' full names to locate the record. If this information can be provided, we will search for the number and, if located, provide a copy of the application. The request can be sent to the Office of Public Inquiries, 6401 Security Boulevard, Baltimore, Maryland 21235.

A fee will be charged to cover the cost of searching our records even if we are unable to locate any information on the person. The fee for searching our records is \$7 when the Social Security number is known and \$16.50 when the Social Security number is unknown or is incorrect. The check should be made payable to the Social Security Administration.

...If a member of the Dallas Genealogical Society has a question, please have them contact their local Social Security office."

To locate your local Social Security office, call toll free 1-800-234-5772. The Genealogy Section at the Dallas Public Library has a form that may be used to order Social Security Records from Maryland: Form SSA-L997, Social Security Number Record Third Party Request. Please request this form at the main desk in the Genealogy Section.

Super Saturday Sponsored by Computer Council of Dallas, Inc. By Art Rubeck

Each month over two thousand computer users attend the free Super Saturday event held at the Infomart in Dallas. It is sponsored by the Computer Council of Dallas, Inc., a nonprofit coalition of computer user groups in the Dallas/Fort Worth area. The affiliated user groups cover nearly every aspect of computing and every type of computer. Meeting dates are usually the second Saturday of each month, but may change due to scheduling conflicts at the Infomart. The next two Super Saturdays are November 10 and December 8. [Check the DGS calendar for future scheduled dates.]

Meetings begin at 9:00 *a.m.* and continue to mid-afternoon. Food is available in several locations. In addition to the free meetings, there is also a trade show, usually in the basement, with area vendors of computer-related items offering bargains on computer hardware, software, and supplies.

Of special interest to genealogists are four genealogy user groups that are part of Super Saturdays: two meet every month and two meet on alternate months. The meetings begin at 9:00 *a.m.* with the Genealogy Special Interest Group, which covers all areas of genealogy and computing. Programs are usually presented by outside speakers on topics of interest to all users. Two libraries are available: a paper library of magazines and other computer-related literature and a disk library of

verify your relationship to the family. Be sure to mention who sent you the address when writing. Let them know what you want, when you will need it, and what you will do when you receive it, such as keep it, return it, copy it, etc. Provide forms to fill out and self-addressed, stamped envelopes.

Encourage them to provide additional addresses. Send out a one to two page newsletter every three to six months to keep the family updated on your progress. If you need to change your target date for completion, tell them, and let them know the reason.

Be prepared to spend time and money to pull the information together. Arrange in advance if you plan to have family members help fund the project."

Madilyn's books can be seen in the Genealogy Section at the library. Her work in progress is a family history for the Henry Family of Texas. computer-related software programs.

The first of three software-specific groups meets at 10:00 a.m., usually in the same room as the general meeting. This is the *Personal Ancestral File* (*P.A.F.*) users group, sponsored by DALTRUG. It is led by Travis Morris, who brings his own computer to demonstrate the actual operation of the *P.A.F.* program. Topics vary from answering beginners questions to advanced uses of *P.A.F.* and related utility programs. This group also maintains a disk library of software programs and files.

On odd-numbered months, the P.A.F. meeting is followed at 11:00 a.m. by a similar meeting for users of the Family Roots genealogy software program. This group, headed by Joyce Jones, explores the uses of the various versions and features of Family Roots.

On even-numbered months, the *Roots III* users group meets at this time and follows a similar format. Don Raney has been both the *Roots III* local distributor and group leader, but this has been taken over by John Wylie, who recently moved from Colorado. Wylie has a widespread interest and knowledge of computer-genealogy topics.

A voice-mail telephone number is available to find information about Super Saturdays. In addition, Margaret Ann Thetford's "Family Tree" column in *The Dallas Morning News* usually carries a notice of upcoming meetings. A complete schedule is available for STARTEXT subscribers under the key word CCD1.

The Infomart is located at 1950 Stemmons Freeway, north of Oak Lawn Avenue.

Guide To Resources in the Dallas Public Library Genealogy Collection

The GENEALOGICAL PERIODICAL ANNUAL INDEX

Overview:

The Genealogical Periodical Annual Index (GPAI), is a comprehensive surname, locality, subject, and book review index to articles of English-language genealogical periodicals. GPAI is compiled by Karen T. Ackermann and edited by Laird C. Towle, Ph.D.

GPAI indexes only those periodicals contributed by their publishers for this purpose. (The 1988 index covers 274 genealogical periodicals.)

Content:

The citations are primarily of four types:

- * Surnames: In most cases, indexed under the name of the male head of household or family (surname, then given name); followed by date of birth, marriage, or death (or approximate dates), name of spouse, and localities covered in article. Spouses are cross indexed. (Check variant spellings of surnames.) This is followed by a description of the type of article using abbreviations such as "geneal" (compiled genealogical record covering three or more generations), "fam rec" (brief description covering one or two generations), "Bible rec", etc. Surname journals are referenced, but not indexed in detail.
- ⁴ Locality: Citations are indexed under the appropriate geographical heading. (Check all names by which a locality may have been known.) United States locations are arranged by states; foreign locations by country, then state or province. Citations include a description of the type of records appearing in the article and time period covered.
- * Subject: Topics other than surname or locality are indexed as to content of the article, followed by a brief description of the contents of the article. Society news and reprinted material are not indexed.
- * Book Reviews: Indexed under surname, locality, or subject, but citation identified as "bk rev".

Location:

Aids:

GPAI (27 volumes) is located on aisle 1, call number R016.929 G326.

Code letters identifying the periodical are located at the end of each citation, followed by volume and beginning page number. A table located at the beginning of the book lists the code letters for each periodical indexed, name and address of the publisher, and specific issues indexed.

Many abbreviations are used in the citations. Most are self-evident, but a table of abbreviations is located at the beginning of the book for reference.

The Genealogy Section (DPL) owns many of the publications cited in *Genealogical Periodical Annual Index (GPAI)*. Ask a staff member's assistance in locating a call number for the publication. If DPL does not own the issue, some material can be obtained through Interlibrary Loan.

Follow-up on "Guides to Resources"

The NATIONAL UNION CATALOG OF MANUSCRIPT COLLECTIONS (NUCMC)

A "guide" on NUCMC was featured in the March 1990 (Volume 14, No. 3) issue of the DGS Newsletter. The Genealogy Section now has the Index to Personal Names in the National Union Catalog of Manuscript Collections, a cumulative index to the more than two dozen volumes of NUCMC (call number R016.091N277, aisle 1).

The index is in two volumes, A-K and L-Z, and covers the years 1959-84. The index is located on aisle 1, call number R011.31 I38.
