

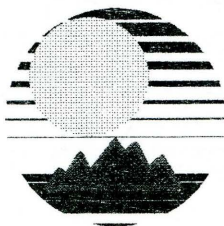

INSTITUTE
22-25 JULY 1999**

As you can tell by the title, we are having a one-topic institute this year that begins on Thursday night and lasts through 1:00 PM Sunday. Hopefully, this schedule will make it easier for working people to attend. The classes will be held at the Dallas Public Library. Friday and Saturday evenings (when the library is normally closed) will be open to us as part of the Institute.

Two experts in the field of land records and platting, Mary McCampbell Bell and Birdie Monk Holsclaw, will conduct the classes and platting sessions. Lloyd Bockstruck will give the opening session on the land records available in the genealogy section. If you did not get to go to Salt Lake City with the DGS group, you can still find a land record or two to work on during the Institute. Darlene Brimmage of the DPL will introduce the historical and topographical map collections available on the 6th floor.

From Thursday evening until Sunday afternoon you will be immersed in land records, both metes and bounds states and public land states; learning the terminology and reading patents, grants, deeds; and most importantly learning how to plat those deeds and place them on modern topographical maps. Land analysis is a very important and essential part of the study of your family history.

Registration is \$200.00 and covers the land platting kit, lunches both days, and brunch on Sunday. Registration is limited to **100 pre-paid by 1 July**. We cannot allow walk-ins as materials must be bought ahead of time. The brunch and classes on Sunday will be held at the Ramada Plaza Hotel, 214.421.1083. The Institute has a block of rooms reserved until 1 July. Since we are staying at the library until 9:00 each

night, it will be very convenient to room at the hotel and use their shuttle to the library. Our group rate is \$89.00 per double occupancy room.

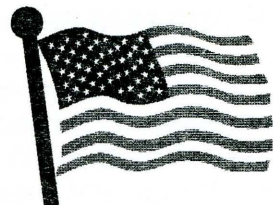

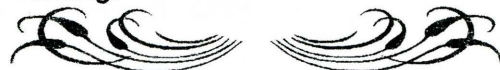
Editor's 2p

REPORT TO THE DALLAS GENEALOGICAL SOCIETY GENERAL BUSINESS MEETING

~PROPOSED BYLAWS CHANGES~

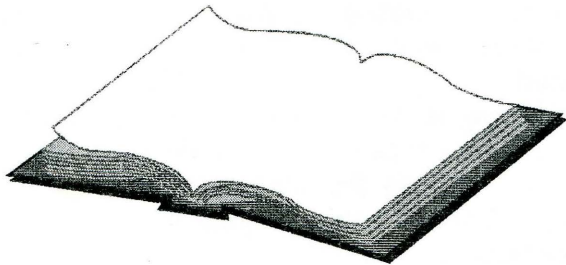
The Board of Officers and Directors, in a regularly scheduled Board Meeting on April 14, 1999, unanimously recommended a proposed change to Bylaws of the Dallas Genealogical Society. The Board recommended the following be approved for presentation to the general membership at the 19 April 1999 Business Meeting.

The proposed changes were presented to the membership at the 19 April 1999, published in the May 1999 *DGS Newsletter* and will be voted on by the general membership at the 17 May 1999 Business Meeting.

Article IX, - Standing and Special Committees Section 2. Standing Committees

The Audit Financial Review Committee: An audit A committee of at least three (3) members shall be appointed by the president at least thirty days (30) days before the annual meeting in May, shall ~~audit or have audited the Society's financial books, and shall report at the annual meeting.~~ in May to review the Society's current financial statement and shall report to the budget committee and to the board in August and to the membership in September.

Reason: The change is to have the ByLaws reflect actual practice. The Society cannot completely review its status until after the May bank statement has been received and reconciled in June. The Society has historically had a financial review of the books and not a true audit by accounting standards. It is important to describe the actual practice in the Bylaws' wording.

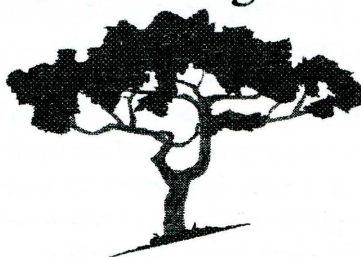

Adventures in Genealogy: Getting Started, OR *Rednecks*, *Class Projects*, and *Climbing the* *Family Tree*

There's a lot of good reasons for startin' to research your family roots; medical history, lookin' for rich uncles, slow Saturday nights, ego gratification, basic curiosity, or as in my case, a homework assignment. About four years ago my oldest daughter was assigned the task of makin' a four generation family tree, and to write as much history about them as she knew. We all sat down at the kitchen table and started buildin' the tree. The first generation was easy; that was me and my "blonde" (although gettin' her to admit her age was a *toughie*). We knew our birthdays, wedding date, and important places. The second generation (our parents) was a little harder. I mean, I knew my dad was born in "back woods Alabama" but I had no ideal which patch of woods. So we made a few phone calls and found out some interestin' things. Dad was born in Tuscaloosa County. Momma's middle name is Emma, LV (my "blonde's" dad) is really LV (they ain't initials), and her momma was from Mineola, Texas.

Now I was gettin' full of it myself at this point. We were halfway thru and it was still an hour 'til the game started. Then my kid started in askin' questions that reminded me of why I'd always believed children should be seen and not heard.

My daughter asked me, "What was Granpa Moore's full name." I sat there for a minute lookin' at her and then said, "Aaahhhh, Granpa?"

"Where was he born?"

"Aaahhh . . . Texas!"

"When was he born?"

"Aaahhh, a long time ago!"

"When did he marry Granma Moore?"

"August."

She gave me that puppy dog look and said, "Dad, you ain't helpin' a whole lot."

Okay, so I went back to the phone. Eunice Francis Moore . . . Delta County, Texas. . . June 2, 1914

Aug. 19, 1931. Then we went through the same tortured process with my "blonde's" grandparents except we couldn't find most of the stuff, so we moved on to my dad's family. I wasn't worried about this one 'cause I grew up listenin' to stories about Granpa Hocutt; William Jackson Hocutt, Tuscaloosa County, Alabama, 12 April 1859, married Grandma in 1910. Then I realized the only thing I knew about Grandma Hocutt was that she didn't have indoor plumbing when I was a kid, and she made great fried chicken. Well, back to the phone, but all Dad could add was that her name was "Stella." (Three years later I discovered her name was actually Mary Estella).

Then we tried the 4th generation back. It quickly became obvious we only knew three out of 16 names. At this point any normal person would've said we'd done our best, let's move on. I guess either I was born with the "genealogy bug" or I just enjoy torturing myself because I said that wasn't good enough.

We spent the next six weeks annoying my relatives and visitin' cousins that I ain't seen in 25 years. (And let me tell you they got bald and fat!) We didn't make much progress.

At this point I'd run out of ideals and was thinkin' about giving up. Then my sweet "blonde" suggested I either get a book that could tell me how to find the rest or I try searchin' on the Internet. Well, duh, I never thought of that!

I went on line and found out about all the tools out there. I learned about FHC's (Family History Centers) which are staffed by real nice people that almost laughed at my questions. I found out about court houses and what all is available there, much to the dismay of county clerks all over North Texas. Thus began my adventures in Genealogy.

Once again we have reached the end of an *Adventure* with some lessons learned. (1) Start with yourself and work backwards. (2) Don't get discouraged when you realize you don't know your grandma's maiden name. (3) There are lots of tools available to help you in your research. (4) Don't ever worry about asking dumb questions. You can't possibly ask any dumber than I did. (5) Courthouses are a treasure trove of good information, and finally, (6) The Dallas Public Library, down town, is a fantastic research facility (Yeah, I know I didn't mention it, but it's too good a resource to leave out!)

⇒ FAMILY HISTORY RADIO SHOW UPDATE

The Family History Show has been canceled on KPRC Radio in Houston (a major loss) but continues on about 16 Texas radio stations including KRLD 1080. The program is currently being carried LIVE on the Internet via KTSA Radio in San Antonio. The expressed reason for the cancellation in Houston was "poor ratings" however, participation from Houston area listeners during the past three years has been exceptional" according to the host and originator, Michael Matthews of Dallas.

Speaking at a Houston Genealogical Forum meeting in early April, Matthews noted that fully 90% of the nearly 200 attending members reported listening to the program regularly prior to the cancellation. "It is more likely due to the fact that there is no consistent advertising support for the program."

Participation (call-in questions for guests) from the Dallas-Fort Worth area has decreased in the past year, which does not bode well for the continuation of the program due to the loss of the Houston audience. The program has been successful for more than four years, which is very significant for a "special interest" radio talk-show, and has helped foster an increased interest in genealogy throughout Texas.

Many nationally-known guests have contributed to educating listening, family historians on proper research techniques and advanced methods and resources, as well as "getting started." The caliber of guests can help any experienced genealogist, but Matthews says a primary goal is to inspire newcomers through the airwaves.

During the Texas Rangers' baseball season currently underway, the program will be subject to partial or full pre-emption a total of 11 Sunday evenings beginning April 11th, sometimes joined-in-progress during the final hour. The Internet broadcasts, through KTSA, provide an alternate access for DFW listeners with the equipment and RealAudio software, but due in part to a lack of local society support for the program in San Antonio, the continuation of the broadcast on KTSA remains somewhat tentative.

Matthews, a Dallas Genealogical Society member, is resolved to continue The Family History Show as long as participation warrants the time and effort of

the guests, but adds, "It has been a success as the first 'network' radio talk-show in America for family historians, but all good things eventually come to an end, and maybe this has almost run its course. But I haven't given in yet."

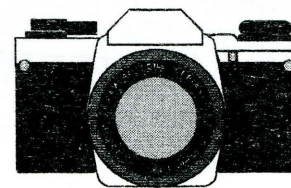

Recent Acquisitions

In 1998 we indicated that in an attempt to eliminate the backlog of new acquisitions, we would limit the list of the new titles to the microforms added to the library's holdings until we were current. 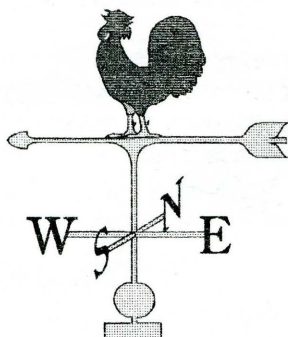

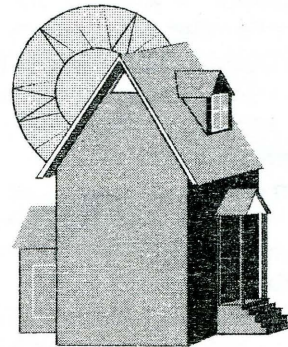

In clearing out my mother's belongings after her death in 1995, I now have a framed portrait of a gentleman we cannot identify. My best guess regarding the age of the picture, based on my best guesses about the frame (not quite rectangular, domed glass) dates it to be around 1880-1910. The portrait is slightly tinted, and I'm not sure whether it's a photo or a drawing. Written on the back is a note: "Mrs. J.O. Rhymes, Paid, Temple, TX."

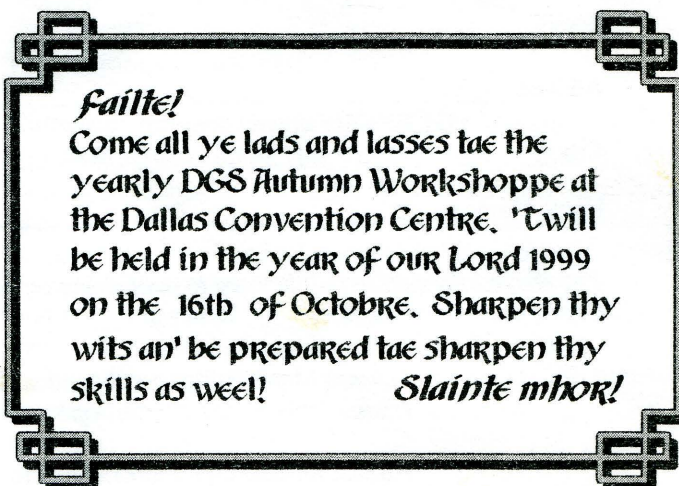

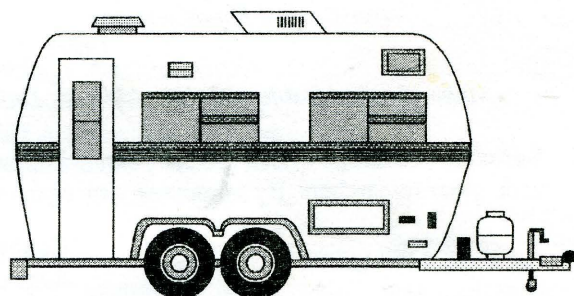
