WHAT IS A QUALITY FAMILY HISTORY?—TODAY'S STANDARDS

Today's technology makes it relatively easy to produce a family history that is pretty to look at. But, as the saying goes, "Pretty is as pretty does." What does it take to make that pretty family history do something—contribute something worthwhile to genealogy? A few key items determine if a book is well-received by your family and by other researchers.

ORGANIZING FAMILY INFORMATION—NUMBERING SYSTEMS AND PRESENTATION

Genealogical numbering systems are much more than numbers, They are ways of presenting multigenerational information. But the numbering system is just the tip of the iceberg when presenting family information. The way you format and structure the text can make a significant difference in how readable, understandable, and interesting your family history is.

HOW DO YOU KNOW?—DOCUMENTATION & EVIDENCE

Source, citation, documentation, evidence, analysis, proof . . . What do these terms mean—and how do we record them to share with others? How much do we need to include in our family history—and where and how do we include it?

MORE THAN DATES—TURNING PAPER INTO PEOPLE AND WRITING THE NARRATIVE

Help your readers understand that these aren't names on paper—they are your family, they are real people. By learning about the context of our ancestors' lives, we can perform magic. We can turn those scraps of paper, those pieces of data, into people—and share that magic with others.

1999-2000 LECTURE SERIES Tracking Your Ancestors in the New Millennium

Saturday, 12 February

"Finding Them in the Midwest; Illinois, Indiana & Ohio"

Lloyd DeWitt Bockstruck, F.N.G.S.

From Whence They Came; Migration Patterns to the Midwest explains origins of the first settlers who came to the Midwest. Settlers came from places such as the Carolinas, Tennessee, Virginia, Kentucky, Maryland, Pennsylvania and New England. Researchers must know migration routes and the history of an area to begin their search.

Records & How to Access them Throughout the Midwest explains and describes the records that resulted from the settlements from their beginnings through the 1920's. Addresses the records created by individuals, and guides the researcher to records in courts both at the state and county level, archives, and other public locations. Other pertinent research tools are covered.

Research in Midwest Records discusses how we can prepare for researching records in person, through correspondence and using microfilm. How to conduct the search of records using repositories of the Midwest, published indexes, maps, and other research tools.

The Ancestor's Final Destinations examines the original records and published materials available to discover the particular facts of your own ancestor's story, and shows how to assemble those facts into a story that conveys both the drama and individuality of the migration experience.

"Technology, Software & Mapping Tools"

James Slade

Tracking Ancestors Using Technology explains ways to track our ancestors using computer technology methods. Case studies will be used to demonstrate how a family can be tracked using deeds, wills, marriage records acquired via internet, email and various other software programs.

Mapping Ancestors: Using Technology and Software to Locate Where They Lived discusses mapping software programs and demonstrations on how to use these programs to locate your ancestor's land.

Getting the Most from the IGI discusses using the IGI, what to look for in the collection, and what will help with locating vital information on your ancestors. Techniques are given to best utilize the International Genealogical Indexes.

Technology Visits the Courthouse, Library, and Archives Explains how using technology at these locations will assist you. Examples are shown to illustrate how to use technology at repositories and how to make the best use with records to be found at there. Mr. Slade uses computer technology and software programs with records, and will help us to understand and use this technology at repositories.

BEING CREATIVE WITH TROUBLESOME KIN

You are working on your family genealogy and for sake of example, let's say that your great-great uncle, Remus Starr, a fellow lacking in character, was hanged for horse stealing and train robbery in Montana in 1889. A cousin has supplied you with the only known photograph of Remus, showing him standing on the gallows. On the back of the picture are the words: "Remus Starr: Horse thief, sent to Montana Territorial Prison, 1885. Escaped 1887, robbed the Montana Flyer six times. Caught by Pinkerton detectives, convicted and hanged, 1889."

Pretty grim situation, right? But let's revise things a bit. We simply crop the picture, scan in an enlarged image and edit it with image processing software so that all that is seen is a head shot. Next, we rewrite the text: "Remus Starr was a famous cowboy in the Montana Territory. His business empire grew to include acquisition of valuable equestrian assets and intimate dealings with the Montana railroad. Beginning in 1885, he devoted several years of his life to service at a government facility, finally taking leave to resume his dealings with the railroad. In 1887, he was a key player in a vital investigation run by the renowned Pinkerton Detective Agency. In 1889, Remus passed away during an important civic function held in his honor when the platform upon which he was standing collapsed."

Treasures Hiding in Supplemental Censuses Barbara Dossett

There are many records available to researchers today in the family hunting game. Many people have learned to locate city directories, state censuses, tax lists, territorial censuses, as well as courthouse records. However, many people don't realize that along with the Federal Census taken every ten years there were other supplemental schedules created at the same time. Further, many of those particular records are readily available. I hope to show that with an understanding of these schedules and charts to show you where they are located and that you will add them to your research sources.

The first step in Federal Censuses that the researcher will do is locate an index to the population schedule and then the schedule itself. The information is then extrapolated into the family information and then the search continues to the next population schedule. However, the government began taking extra information with the 1850 Census count and created those supplemental schedules. The Federal government created Agricultural, Mortality, Industry/Manufacture, Defective, Delinguent, Dependent, Slave, and Social **Statistics** Schedules. There are some early Manufacturing schedules in 1820 and 1832. Some of these schedules continue even to today. Now that is a mouth full of schedules. They can be overwhelming. But good research means that you should collect all available records.

A simple method of collection that I have developed to gather my records is AIMS, DDD, and SS. By following this pattern with each and every ancestor you will create a fuller picture of the family and the community he lives in.

AIMS is the Agriculture, Industry/Manufacture, Mortality, and Slave Schedules. In the following pages I have created charts for each of these schedules and their locations.

The Agriculture schedule includes questions about the farmer, his lands, his crops, produce,

his animals, and those things that the family manufactured on the farm such as eggs, butter, and homemade goods. This gives a good picture of the family at work and being self-sufficient.

For those individuals who don't have farms, the Industry/Manufacture schedules come into play. You could find your blacksmith, tailor, or some other business. Again you can see how your family fits into what the neighborhood is doing.

The Federal Government also asked about the deceased for four of the Censuses—1850-1880. It wanted to know who died the year prior to the census. This makes for a wonderful death certificate substitute. The questions included the name, age, sec, color, the cause of death, occupation and month of death. It makes you wish everyone were on the Mortality Schedule.

For the 1850 and 1860 the Federal Government asked questions about slaves. They wanted to know about the number of slaves, their ages, sex, and color. Most schedules do not reflect the names of the slaves, but be sure to check because some schedules have the slave names. Again this is part of your ancestor's life.

If you are having some trouble locating all these schedules be sure to pull the tax roll for the year in question. You want to be sure that you match as much as possible the information from all the sets of records available.

In 1880 there was a new schedule called the Defective, Delinquent, and Dependent schedule. Again the government wanted more information about certain situations. It wanted to know about those people who were in poor houses or prisons. The government wanted to know if there was certain afflictions such as deaf-mute, blind or homeless children, insane or indigent persons that made them dependent on others. Again this is another snap-shot of your ancestor's community.

Finally one further schedule made which doesn't show individuals but rather the community is the Social Statistics Schedule. This report shows the breakdown of the county by number of schools, churches, libraries, newspapers, paupers, and wages earned in the county. This could help you determine what existed in the community and should send you searching for those records.

The following charts help you locate where those supplemental schedules are hiding. I have shown where they might be hiding. As you can see, the Dallas Public Library and NARA contain many of them. The difficulty is how to gather them. Contact the librarian for the special collection at the institution or repository where the records reside. Ask if they have been microfilmed. If they have, ask for their number and order them through interlibrary loan. For example: the Texas Agriculture Schedules have been microfilmed and are available from the Texas State Archives and can be ordered from your library and usually for free.

I hope that these charts (see following pages) will help you overcome some of those brick walls in your research. This group of records should be part of your search when you do the population schedules. The Federal Census is not complete unless you have all the parts.
