

Who was the Father of Lorenzo Dow Moreland?

No records can be found indicating Lorenzo Dow Moreland's date of birth, death, burial or ownership of property, which makes it difficult to determine his parentage. However, using other records, genealogical proof can be found and these provide clues to who was his father.

Hannah Willis married Hazle Moreland on 8 January 1785 in Rowan County, North Carolina. In a mortgage dated 16 July 1821 between the State Bank of Illinois in Gallatin County and her husband, she surrendered her dower rights to property being held as surety in case of default. Hannah and Hazle Moreland's children were Hazle Jr., Vincent, Willis, Gardner, Nancy, James and Rachael but none of their sons had a son named Lorenzo as indicated in subsequent records searches.

James Moreland purchased land at the Land Office at Shawneetown, Illinois on 14 October 1814³. James made subsequent payments at the Shawneetown Land Office through 1820. Neither the 1818 Illinois state census nor the 1820 US census lists James Moreland. On 9 January 1821, James Moreland assigned to his brother Hazle Moreland Jr., his land purchased from the Land Office in Shawneetown, signing his name.⁴

On 2 October 1822 Willis Moreland and Hazle Moreland, Senior were appointed administrators of the estate of James Moreland, bound for \$800.00.⁵ If Lorenzo Moreland is the son of James Moreland, he was left an orphan at the age of seven.

After Hazle Moreland's death, Hannah appears in the 1830 census of Phillips County, Arkansas located on the Mississippi River. The household contained 8 individuals. One female, between the ages of 60-70, is Hannah and 3 males. One male "of ten and under fifteen" could be Lorenzo Moreland. (The remaining 2 males, one is "twenty and under thirty", and the other is "thirty and under forty.") If this is Lorenzo, he was living with his grandmother, Hannah in 1830.

The first civil document bearing Lorenzo Moreland's name was a marriage record in Alexander County, Illinois on 15 May 1834 with Elizabeth Pennington as the bride. In 1839, he was a taxpayer in Searcy Township, Phillips County, Arkansas. From this it can be inferred Lorenzo traveled between southern Illinois and Phillips County, Arkansas.

The 1840 US Census, Phillips County, Arkansas lists Lorenzo Moreland in a household containing two individuals: one male age 20-30 and one female age 20-30. The 1850 US Census, Phillips County, Arkansas shows Lorenzo Moreland, and his second wife, Mary Ann McClain. No record of this marriage has been found. Lorenzo's age was 36 years, indicating his birth date is 1814/1815. Also, listed was daughter Mary E., who was born in 1849. The second daughter, Martha E., was born in 1852 in Arkansas. Between 1852 and 1855, Lorenzo Moreland moved back to Gallatin County Illinois with his family. His son James Alexander Moreland was born in Illinois in 1855 (as were the subsequent siblings). 11

Lorenzo Moreland died in 1864 or early 1865. No record has been found of his death, burial or probate. There were four surviving children. Martha E., James Alexander, Sarah and Mahala J. His wife, Mary Ann married Patrick Henry in Gallatin County on 10 March 1865. In the 1870 census, all the children are listed with the last name of Henry. Their step-father, Patrick Henry was the head of household.

There is no direct evidence and little indirect evidence that Lorenzo Moreland's father was James Moreland; however, when all the evidence is combined it indicates that this is true.

Free Online Source for VA Pension Payment Cards, 1907-1933

My ancestors all came to the U.S. after the Civil War. However, my research for my sister-in-law revealed several Texas ancestors who might possibly have served in that war. Unfortunately, I have never been able to find any of them either on Ancestry.com or Fold 3.com (formerly Footnote.com).

I recently read of a new free online source for searching Civil War ancestors, namely *VA Pension Payment Cards*, 1907-1933 on Internet Archive at:

http://www.archive.org/details/veteransadminpensionpaymentcards

This database previously was available only as microfilm M850 at NARA, based on Veterans Administration Cards in Record Group 15. The Allen County Public Library in Fort Wayne, Indiana digitized the microfilm and posted it at the address above.

The database contains two million cards showing payments between 1907 and 1933 to Army and Navy pensioners, and to their eligible widows. In many cases it contains more information than that available at either Ancestry.com or Fold3.com.

Each card has a front and back side, so there are at least two images per person, with some individuals having more than two cards to record more information. The cards were microfilmed by first taking an image of two cards, then turning them over to take an image of the backs of the same two cards.

Therefore, you read the cards across the page, not top to bottom. The default view is two pages per screen, so there will be four cards on each screen you see.

The front of Person A's card is at the top left, the back of the same person is at the top right. Similarly, the front of Person B's card is at the bottom left, and the back at the bottom right. Note that if the person has multiple cards, you can track that you still are looking at the same person by checking the pension certificate number that appears on the front and back of each card.

The bad news is that the cards are not searchable. However, there is a finding aid created by Arne Trelvik and posted at the Warren County OH Gen Web project:

www.rootsweb.ancestry.com/~ohwarren/military/pension1907 1933.htm

Note that this finding aid is for all 2539 microfilm rolls, not just those for the state of Ohio. You can click on the alphabetical range where your desired surname falls (in my sister-in-law's case, the surname Kellner is on Roll 1227, between Kelley and Kellogg), and it will take you directly to that roll. You can either read it online or download it as a PDF document.

There are zoom controls to better read the cards, forward-backward arrows to move through the cards one at a time, and a slider at the bottom of the page to move through the entire roll very quickly.

Using my Firefox browser I was able to print a screen shot of all four cards, but it was very small. When I switched to a one-page view, with only two cards, nothing would print. I'm not computer-savvy enough to explore other options for printing.

Unfortunately, I did not find any relevant Kellner ancestors, but perhaps you will have better success!

You can read about this database and its use in more detail in the Fall 2011 edition of *Ohio Genealogy News*, which is among the genealogy society publications available at the Central Branch of the Dallas Public Library, 8th Floor Genealogy Section.

BillionGraves Initiative

FindAGrave.com has been around for a while, but now there is a new website and a new smart phone app for those seeking photos of headstones and grave markers.

BillionGraves is an app for smart phones that allows photos of graves to be uploaded to BillionGraves.com. If the smart phone includes technology that includes GPS data each image will include specific location data for that grave.

The app is free for download in the Android Market and the Amazon Superstore for Android, and on Apple's iTunes App Store.

Once photos are on the website, anyone can help transcribe the information from the headstones, aiding in the search for a specific ancestor's grave marker.

Users who register on the website can upload photos, add new cemeteries, or do transcriptions.

Searches can be done either for a person or for a cemetery. I was able to search even without registering.

I wasn't able to find any specific ancestor headstones, but I was able to search for cemeteries in Dallas County, and found 62 listed. The number of photos per cemetery differed greatly (12 for Restland in Richardson, none for Oak Cliff or many others).

Two things I found annoying:

- when doing a cemetery search when you use the drop down box to select country, state, then county, the results you pick don't actually appear in the boxes
- after clicking on a cemetery to view the records, if you use the back button it doesn't return you to the results list (e.g. all cemeteries in Dallas County), but to the Search page for people, not cemeteries.

You can also enter the name and location of the cemetery directly into the search field.

At this point the site indicates that 122,136 cemeteries in the United States are searchable, but many of them yield no photos as of yet. Cemeteries outside the U.S. are not as well represented. This website and app are definitely a work in progress. It will be interesting to see how it plays out.

Ask the DGS

Would you like to pick the collective brain of our talented membership? Perhaps you would like a recommendation of a web site or reference book that focuses on a specific type of family research or a particular geographic region? Could you use some tips and tricks to help you with a research problem? Would you like to ask how to accomplish a certain task in your genealogy software program or how to cite an unusual source?

One of the blogs which we have created on the DGS web site is *Ask the DGS*. As Secretary, I am its administrator/monitor. I encourage Newsletter readers to send me questions that you would like to pose to our members. I will post them to *Ask the DGS* where others will be able to read them and respond. It sometimes "takes a community" to solve a genealogy problem!

How it works... In order to control spam and other unwanted items, the administrator initiates each request, called a Post. Once a Post is added to the blog, readers can then respond to it without the administrator being an intermediary. These responses are called Comments; click on "Leave a comment" just below the message to which you would like to respond. If others have responded before you, the link says "1 Comment," "2 Comments," etc. instead of "Leave a comment."

As readers comment on the comments of others to the original post, a discussion thread develops which builds on and expands upon the information contained in the messages.

Library Lock-ins Fall Prey to Low Attendance and City Budget Cuts

DGS will not have a Genealogy "Lock-in" this year. The participation in the last several lock-ins was disappointing. When the lock-ins began, nearly 100 people participated. Only about 30 individuals participated in the last two lock-ins.

Low participation meant that the funds generated were not enough to cover the costs to operate the lock-in (i.e. security, food). The cost of security for the last lock-in was \$200.

Additionally, the reduction in library staff due to city budget cuts has tightened up the schedule of the genealogy staff making it impossible for them to be available. The library had paid the staff to be on hand for the lock-ins.
