Honoree: In its History of Medicine and Archives collections, the Library has collected and preserved photographs, publications and unpublished papers that cover the historical aspects of health care, with a focus on Texas and the United States. Record groups include a history of Dallas County medical organizations from 1894 to the present, and a large collection of digitized images that portray institutions, people, and events

which played a role in the progress of medicine and medical care in Dallas.

LLOYD BOCKSTRUCK DISTINGUISHED SERVICE AWARD-HELEN F. M. LEARY

Genealogists. Helen is recognized for her many scholarly contributions to genealogy research, and is well-known for her entertaining and informative lecture style. During her 30-plus-year career, her contributions have ranged from publishing scholarly books and journals to creating webinars for the internet.

VOLUNTEER OF THE YEAR AWARD-JANET KHASHAB AND MARIANNE SZABO

This award acknowledges members who have generously volunteered time, expertise, talents, and abilities to the Society during the previous year.

Winners of the 2013 DGS Writing Contest

The entries to the 2013 DGS Writing Contest were evaluated by the Publications Committee and by professional genealogist J. Mark Lowe, under the criteria outlined in the Contest Rules:

• Accuracy: 1 to 15 points

• Clarity and writing mechanics: 1 to 20 points

• Overall impact and interest: 1 to 15 points

Individual judges' scores were averaged for each entry. An entry had to receive an average of at least 25 points to be eligible for a prize.

FROM KENTUCKY TO TEXAS: THE STORY OF ONE PIONEER FAMILY

SECOND PRIZE-\$300

A DOUBLE MURDER IN MILLS COUNTY BY CHARLES (CHUCK) CURTIS (DGS MEMBER)

Chuck Curtis became interested in genealogy after he saw an Ancestry.com commercial in 2010. He was inspired to write about the events in his entry by his daughter-in-law, who "told me somewhat timidly that her great-grandfather may have been

involved in a murder and may not have served time for it. This was live waving a tennis ball in front of a golden retriever and I was off on the hunt!"



That hunt led him through archives, museums, newspapers, trial transcripts, and interviews with people who had attended the trial. He

also visited the site of the murders. He wanted to document what he found for his grandson and decided to enter the Contest because "it provided a deadline, and clear rules about length, subject, endnotes, etc." He's filed the manuscript, his notes, and copies of all his sources in a bright red file box for his grandson to read in the future.

He holds Bachelor of Journalism and Master of Arts degrees from the University of Missouri.

He moved to Dallas when he retired in 2006. He served on the North Texas Crime Stoppers Board from 2007 to 2010 and was the Chairman of the North Texas Crime Commission in 2010. Chuck became a member of DGS in December 2013.

Obituary: Madilyn Louise Coen Crane Held many DGS Board positions in the 1980s and 1990s

Madilyn Louise Coen Crane died Sunday, December 8, at her home in Austin, Texas, after a long battle with cancer. She was the VP Journal for the *Dallas Quarterly* 1989-1991, executive VP Fundraising 1991-1992, Parliamentarian 1993-1994, and VP Publicity 1996-1997. She was still a member of DGS at the time of her death. From 1995 to 2005 she was office manager for FGS and received the President's Citation for her work.




Laura G. Prescott to be Featured Speaker for DGS Spring Lecture March 22, 2014

Registration is open for the DGS Spring Lecture 2014 to be held Saturday, March 22, 2014, at the J. Eric Jonsson Central Library. Our featured speaker is Laura G. Prescott, a professional researcher and writer.

Laura graduated with a B.A. in History from Dartmouth College in 1980, ultimately putting her degree to good use over a decade later when she discovered a latent passion for genealogy.

She worked for the New England Historic Genealogical Society for seven years before starting her own research business. Originally from Charleston, West Virginia, she has lived in New England for over thirty-five years.





Her articles have appeared in *Ancestry*, *New England Ancestors*, *Genealogical Computing*, *NGS Magazine*, and *Digital Genealogist*.

Topics to be presented at the DGS Spring Lecture include:

Playing Hide-and-Seek with Ancestors in City Directories— Explore the history and growth of city directories, discover their value to genealogists researching urban and suburban families, and learn tricks and tips in using them to trace family migrations, address changes, careers, and events.

Timelines: Placing Your Heritage in Historical Perspective— Match historical events to an ancestor's life, or synchronize one ancestor's events to another's through timelines. Literally the outlines of our ancestors' lives, timelines lead us to solutions and surprises.

Treasures within the Ivory Tower: Finding Family in Academic Archives—College and university libraries are historical repositories for their communities and their special collections are overlooked resources. Your ancestors did not have to attend a college for you to find them through this unique town-and-gown connection. Learn where to look, what you can find, and the most efficient techniques to get the information you seek.

The Rest of the Story: Using Manuscripts to Create a Family History—Tap into great repositories of historical treasure! Discover where to find information about your ancestors in special collections and why manuscripts and artifacts are essential to building your family's story.

Where's Pegasus? - Corrections to Its History

Some details of the history of the Magnolia Building and of

the location of the original pegasus neon sign were incorrect in the Premiere Issue of *Pegasus*. The sign in the Old Red Court House is one that sat atop the Casa Linda Mobil Station near White Rock Lake. The original sign had been stored at the Dallas Office of Cultural Affairs Public Art



Storage Unit, but was recently removed from storage for condition inspection and renovation

First erected in 1934 on the roof of the Magnolia Petroleum Co. headquarters on Commerce Street, the winged horse sign, fabricated by Texlite Signs in Dallas, became one of Dallas's most enduring and recognizable landmarks. In 1959 it became the logo of Mobil Oil when it merged with Magnolia Petroleum. The city conferred landmark status to the sign in 1973. In 1976 it became the property of the City of Dallas.

In 1978 the Magnolia Building was listed in the National Register of Historic Places. Developers bought the building in 1997 and converted it to the present-day Magnolia Hotel. In anticipation of Dallas's Millennium Celebration, in 1999

the original sign was taken down and put into storage when a new sign was commissioned. A completely new, fully-rotating sign was lit for the first time at midnight on January 1, 2000. This work was accessioned into the Public Art Collection in 2000.

Our thanks to Life Member George L. Bennett for bringing these discrepancies to our attention.



genealogists, with ramily reunions, conferences, or vacations. There is sometimes a letdown after the end-of-the-year holidays, not to mention winter weather that keeps many indoors!

Committee changed the contest dates to the first quarter of the year, in the hopes this might add an incentive for potential entrants to sit down and write something about their ancestors.

As with previous contests, this year's is open to both members and non-members of DGS. Hobbyists, transitional, and professional genealogists are welcome to submit entries. Entries may include genealogies, family histories, and case studies that demonstrate use of genealogical methodology techniques and sources.

While DGS has a goal of preserving Dallas area history, subject matter for the competition is not limited to the local geographic area as defined in the Rules and Guidelines:
