The following "Cross-file of Grantors and Grantees of Town Property in the First Ten Years of the Town of Dallas, 1846-1856", by Robert T. Gill, is an outgrowth of the Dallas Philological Society program for June, 1960, "Lowly Cabin to Lofty Tower -- the Story of Dallas Architecture." Mr. Gill found, in doing research on dates and construction of downtown buildings, much material dealing with land transfers that he felt should be readily and easily available to the public. As a result of this conviction, he spent countless hours at the Dallas County Records Building. Compilation required reading through the first five books of the Dallas County land records, which are complete from the organization of the county. We are fortunate, indeed, to have received his permission to publish this important source material relating to Dallas history and genealogy.

Mr. Gill, whose home is at 1600 West Abram, in Arlington, is a descendant of Dallas pioneers. He is a former Vice President of the Dallas Philological Society, has long been a member of the Board of Directors of the Fort Worth Genealogical Society, is active in the Gathering of the Socitish Clans of Texas at Salado, and is a member of the newly organized Socties Clans of North Texas. He has had many years of research experience in genealogy and history, and is a heraldic artist, working chiefly in metals. He is also a speaker on all his subjects.

# COLLIN COUNTY, TEXAS, CEMETERY RECORDS ALEXANDER AND BAKER CEMETERIES

Abstracts of tombstone incriptions collected from certain old Collin County cemeteries containing graves of many of the first settlers of north Texas. January. 1966.

#### I. Alexander Cemetery

The Alexander Cemetery is located on the original J. M. Kincaid Survey in north central Collin County. This is about 5 miles west of Anna, Texas, and is easily reached by a fair-weather dirt road just off Farm Road 455 between Anna and Weston. An arched cemetery gate sign faces west toward the dirt road.

The earliest marker is that of William Alexander in 1855. In this oldest section of the yard some graves are marked only by bots of 4arc posts or hand fashioned bricks at head and foot. It is not uncommon to find such markers on slave or servant graves within a family plot. One rounded wooden tombstone (uninacribed) has been "grown around" at its base by one of the cemetry's two towering bur oak trees. These non-native oaks were undoubtedly planted by early settlers as were the cemetery's several large native coder recember. Centers were commonly planted at both homesites and graveyards. Their presence can serve as a guide to such places when other signs are no longer at one visible.

## II. Baker Cemetery

The Baker Cemetery is located on the original John Batterton Survey in north central Collin County. This is about 6 miles northwest of Anna, Texas, off Farm Road 455 between Anna and Weston. This cemetery is very difficult to reach as it lies unattended and enclosed by barbed wire on privately owned land. It is about a mile due north of the now abandoned community of Kelly and the rarely traveled dirt road leading toward it dwindles to a trail which ends abruptly. About a thousand yards north of this and hidden from vice by a rise in the land the graveyard sits in the middle of a cultivated field.

The corners are marked by tall native cedars and within is a tangle of undergrowth in a thicket of other trees. Only five tombstones were found but it is possible one could have been missed. Certain ground depressions would indicate graves which had been moved or lie unmarked. All graves are found fairly close together on the west side. The remains of a wood frame entrance or gate can be seen close by on the ground.

# THUMBNAIL SKETCHES A PANORAMA OF DALLAS SOCIAL LIFE - I

As with all the world, so-to-speak, social life in Dallas as elsewhere reflected the Court of Queen Victoria, whose long reign has been divided by historians into three major section - our town's history being influenced largely by the latter two of them, namely the Middle and Late Victorian Eras, Roughly speaking the Middle one was characterized by the discovery and development of the use for steam, approximately from 1850-1890 - the Late Era from 1890 to World War I. In these combined dates another dividing classification or method of grouping changes in living conditions and social customs as well as costumes was or is the upsettings resultant of wars, i.e. the War-Detween-to-States in the 1860s, and the Spanish-American of the 1890s.

It is always most interesting to recall stories of the "early days" in contrast to the changes wrought by the two World Wars also roughly-termed "100 years of Progress" 1860-1960, often tongue-in-cheek referred to as the "Good Old Times", . . if you don't mind mild prevarications.

Heresay, tradition-says, old-folks' faulty memories (many times by no means as "faulty" as the "younger generation" likes to think and say), all contribute to so-called history, wrongly written, wrongly interpreted. Effort is being made in these "Thumbnail Sketchee" to put on paper things as they were, or as they were correctly "reported" to be.

From the 1860s to 1890s professional men habitually wore "Prince Albert", also called "Frock", coats. Their hats were the high top variety of shiny, silky black "beaver" and collapsible, with rather dull silk ones for evening. However, sometimes the hard-top hat was worn both day or evening. Their shirts were tailor (hand-made) silk or soft linens, finely woven, with tiny tucks or ruffled fronts of lace or material. This costume was indicative of the superior education required of a lawyer, doctor, minister, or other professional man, yet later when the "Rough Riders" broke down every social barrier they could, more or less in revolt from the over-niceties that characterized the Late Victorian Period, plus a change in the distribution of wealth, fashions were changed to the other extreme, of drab uniformity.

This also was the era of the "wasp-waist" for women. Flesh and organs were displaced from normal positions to attain the desired contours. The flat-chested building-out their lack with ruffles and the slim-hlpped sporting bustles for cover-up. The revolt against these mal-health practices also went to the other extreme. High help, high button shoes giving way to flat, no heel and "sensible" round-toed, ugly "health" shoes, tight waisted dresses to neo-empire or extremely loose ones, having belts designed merely to separate the blouse from the skirt. These permitted women the privilege of refraining from the necessity of, every two years or less, adding to the family.

Society required the Late Victorian hostess to observe a number of more or less artificial practices. One of these was for little girls or boys to stand at the door with silver trays for the guests to deposit their engraved "calling" cards (indicating attendance at the tea or reception); and the cloths used on the refreshment table(s) to hang below the edge a certain number of inches minimum dependent on the degree of formality the occasion required. Shades were drawn throughout the house, regardless of the time of day, and candles lit, their number and height as well as colored (expensive) or white bespeaking the degree of affluence of the hostess. Generally speaking, buffet and cocktail parties were not the vogue until World War I, in fact any evidence of liquor was definitely not in good taste.

Dinner parties and banquets were usually rather stiff affairs, used primarily to compliment or honor person(s) or occasions. There were strict rules of seating and table appointments that one observed,

When one had been entertained at any function, the custom was to ascertain the hostess! "At Home" day of the week, to be found in the current year's "Blue Book", and "go calling". On this occasion the surrey, carriage, or braugham (the smaller closed carriage, very chic) was brought around to the portecochere and one or more ladies drove from house to house. After leaving cards on the table by the front door of each house visited, there might be a short chat over a cup of tea. Sometimes they merely left their cards, if they had a number of "calls" to make and the distances apart were sufficient to require considerable travel time. Often three generations from a family went together, or one or two would include the card of the other, showing her intentions, if not actual presence. Generally one afternoon a month during "the season" (from November to May) was set aside for small informal tea parties. These were considered proper "calling" days.

Amusing incidents occurred, of course, such as the time the combination coachman, yard boy, butler, et al, did not take time to put on his driver's complete uniform, trusting to the "lap-robe" across his knees to hide his work pants and lack of shoes. Imagine his (and their) chagrin on seeing bare feet and odd looking trousers approaching the front door to deliver cards for the ladies. Ah well! Too late!

"Going calling" was not only a ladies' custom, but Sunday afternoons the young bachelors called from house to house, the popularity of the young ladies being boasted via the number of young men who called in an afternoon, whether regularly accustomed so to do or not. If they had a number of calls that they desired to make in an afternoon, they sometimes arrived before their hostess(es) were ready to receive. In this instance the young gentlemen sat and chewed their fingernails in impatience in the "parlor", or on the porch. Many times in the fall or spring, during mild weather, callers would appear in groups, too many for the usual parlor to accommodate, so the "overflow" would scatter into the yard. This situation, for the young lady, was the height of popularity. A bowl of nuts, or small candies or cookies were the usual refreshments, only occasionally would the dining table ever be used, rather, small coffee tables, that graced the parlor or living room, carried the punch bowl or silver service. This led, naturally, to the informal Sunday night suppers, also "after the Ball", "Coming-out" parties, or any evening entertainment "show", party. For these affairs there was an addition of cold sliced ham, turkey, or other meats and a salad for do-it-yourself snacksthus preparing the way for more elaborate buffets as time went on.

General amusements included balls, dances, the circus, and sports, each of these was quite distinctive. These were the so-called "horse and buggy" days, when kerosene lamps were being replaced by natural gas, and street lights, in general, were still an innovation of the future.

Baseball was almost as popular, as today. . . also tennis, both lawn and table, although "mixed foursomes" presented a bit of a problem, it being the vogue for the girls to express their surprise and delight on the occasion of purely by chance hitting the ball. They had a sort of costume especially designed for wearing when they went out to play the game. This dress resembled a modified version of naval uniform, and which was very special and cherished by all.

Their riding costumes, too, were another important dress fashion. Dependent on the school-of-riding, some were strictly for side-saddle while Others, designed in imitation of the boys' riding astride, were for many years frounced upon.

Croquet was quite popular, too, and old men as well as young boys enjoyed quotis, or horseshoes. There were definite seasons for every one of the "sports", that included; marbles, kites, mumble-the-ped, halloween apple boling, taffy-pulling parties, marshmellow roasts, fudge-making parties, hay-rides that ended with picnic-sport contests (hay-rides being largely the Southern substitute for sleigh-rides as seldom was there enough snow to warrant the kind of entertainments indulged in where winters were less mild). these being an incomplete listing of some types of fun, not forgetting the turn-of-the century skating-rinks (roller skating), bowling-on-the-green or indoors, Leachman's Natatorium (so popular for swimming parties), Kidd Springs, open air summer theatricals in the Oak Cliff theatre as well as at Fair Park, etc.

Speaking of the theatres, aside from the rare appearances of great personages such as Sarah Bernhardt, there was the Oak Cliff Summer theatre with such attractions as the incomparable Ada Meade, and the Vaudeville in winterseason, with its "black-face comedians", many animal acts, tumblers, and tapdancers. There were every day, matinee and evening, performances. The main acts were in the Circus' Big Tent with its three rings, but an important part of the show was the sideshows located at the entrance to the Big Tent. Here were the; pink-snow candy, soda-pop, Fat Woman, the Two-headed Calif, the Strong Man and the Tall one, the Horse-with-its-head-where-its-tail-out-to-be (i.e. tethered with tail to feed-trough, a hoax that the victims were careful not to divulege), the Sword-swallower, the Bellydancer, the Fire-eater, the Woman Sawn-in-half, the Crazy-house, Peek-shows, the Fortune-teller, the Python-charmer, the Hairy Man, and others.

When bicycles were first introduced there were those of the immense i.e. extra-tall, large front wheel, and the small rear one (sometimes seen later on vaudeville) that required quite a bit of dexterity to maintain ones balance. Also, there was the "gig" or two-wheeled sports cart affected by the "beaux" with their gaited horses. . . both being at first largely in the category today enjoyed by a "Thunderbird-convertible" automobile.

Other variants of fashion-emphases include dwelling architecture, which ranthe-gamut from the extreme simplicity of the one room twenty foot all purpose cabin, with or without lean-to shed via the double breeze-way-divided ranch style to the ginger-bread and cupule-bay windowed two-storied mansions of frame, stone, or brick of the 1890s. The next inovation was the picturewindow with centered lamp, to the contemporary spread-eagle one-stories of varied external non-classifiable architectural types, et al.

During the non-censored era of sportsman regulated horse racing, when the arean that preceded the Cotton-bowl at the State Fair Grounds boasted the exclusive Members' Clubhouse with its vantage viewing veranda to which admission was only permitted holders of specially issued cards. Attendance at the races was one of the greatest enjoyed (perhaps) of the out-of-doors entertainments. Amusing incidents in relation to the enforcement of rules for entrance to the Clubhouse include the classic example of the value of family physical resemblance on that day that the card was forgotten and the daughter desired to have some of her friends admitted. What happened? The special policeman (an impressively large, strong man) took one long look at her and dryly remarked with a wave of his hand inward "Go on in. You're marked - Gross Scruggs."

Landmarks of by-gone days seldom survive the generation that produced them. In compliance with the insatiable yen for something new and if possible different that every generation seems to come into the world demanding - accessibility and space requisites sweep out the former to make place for the current needs. Thus, unless one has some sort of record as has been attempted in these "Thumbmail Sketches" of a deliberately panoramic nature, much of the happy side of life, with the methods used to secure it, may be lost. History is quite too dry without personalities, and a tolerant understanding of their problems.

Society may be said to be the playground of the extrovert, while Fashion is the means by which the chief players exhibit their personal preferences, to a large degree their daring, and their leadership abilities.

Social life of adults is, however, only one phase. That of children, notably in their schools and activities, altho by no means as interesting nor as colorful, carries quite as meaningful a range of variations as their eldersimines may be expected to carry, together with certain special characteristics that are definitely their province. There has been a shift in the emphasis of accepted "basics" of education, notably departure from the "spot-light" on the "classics" of literature, history, and general panoramics of the sciences to specializations. There has been a change in attitude toward the mind training, tried and true devices, and restraint and firm control are lessened even to abandonment, resultant problems are evidenced, for a rather colossal ego-itis is the natural outcome.

Graduation exercises in former days held precious memories, evidenced by Reunion reminiscenses. The Christmas tree and Sunday School celebrations, where each child received an apple and a small bag of candy, after the singing of carols and presentation of the adaptation of the old Mummers-Playlets of the occasion. The older teen-agers exchanged mementos which were long cherished. . ah, who has not seen the light in the eyes of later recalling of such events! Sentimental? Of course! But, this way of life was easier-to-

live-with than the other extreme of hardboiled, impersonal, self-centeredness, all too prevalent today. This latter attitude, a mistaken interpretation of much desired sophistication, only evidences again the pendulum swinging from one extreme to its opposite. The median ground, whether reached slowly or quickly, usually is achieved. Following the Universal Law of perpetual change, sooner or later a more balance generation develops. Fortunate indeed are those of that generation!

Customs and costumes invariably, it appears, indicate the prevailing level of advancement (or its opposite), thereby presenting for "he who runs to read" indictment or commendation indelibly written on the pages of history, generation by generation.

Note on: John Dickins Family Bible

On the single page is a record of the family for more than a hundred years - from the birth of the father in 1747 to the death of the son, Asbury, in 1862. #### MARTIN B. LEWIS - LEDGERS

(Through the courtesy of Mr. J. W. Herring, photostatic copies of the Martin B. Lewis Ledgers have been made for deposit in the Texas, Local Hastory & Genealogy Department, Dallas Public Library, and will be available for public use at a later date.)

Martin B. Lewis was an enterprising pioneer in Jasper County, Texas, in the early 1830's. He left at least two ledgers as a record and a memento of his time and place. These ledgers are filled with a miscellany of information.

Found in these is the Lewis Family Record, including both sets of grandparents John and Sarah Lewis, and John and Sarah Lemaster. His parents, Samuel S. and Sarah Lemaster Lewis, were born in Virginia and married in Henry County, Kentucky, but soon thereafter moved to Clark County, Indiana. Typical of their age, the family moved several times in Indiana, but following the marriage of Martin B. Lewis to Nancy Moore October 30, 1825, they moved to "Washeta" (Ouachita) Parish, Louisiana. It was not until 1831 or 1832 that the move was made to Texas, to the Ayick District on the Attoyack River.

Mr. Lewis was a merchant, and in his ledger he kept a record of debts he owed, and those that were owed to him. Some two hundred names of people living in the area are found here. A point of interest is the articles purchased and charged to their accounts.

Books were very rare and quite expensive, so Mr. Lewis copied definitions of legal terms in his ledger. This made a rather comprehensive dictionary to cover his needs. Forty-three pages are given over to this use. This definition is to be found in this section.

A note payable in Texas Money held to mean the promissory notes of the Republic of Texas and not gold and silver. Texas, never having had a mint and it being an established fact Texas has no other actual currency than the promissory notes.

Surveying was another of the several occupations Mr. Lewis followed, so, he included a sort of "How" on surveying in this ledger. The record of land he surveyed and the charge he made for the surveying is given. It is noticeable that the rate of charge varies from person to person. Being a surveyor was a convenience, for Mr. Lewis was a large landholder. A list of his land

holdings, his land sales and purchases, and a slight description of each is given. A poignant story is found in this entry:

640 Acres my own donation which I am entitled by virtue of being in the battle of San Antonio - Situated on Birches Creek North of a Survey the Headright of A. J. Shelby and in Nacogdoches County.

and

Charlotte Harper Lewis a daughter of Martin B. Lewis & Nancy Lewis was born in Texas Jasper County December 14th 1835 - Whilst at the takin of Bexar.

A rare document, "A Musterrole For Beat No. 1 Jasper County, Texas, August 3, 1961" is made up of the names of the younger generation men of the area, Many names are not found listed in prior years, but there are a few from the earlier list. No Lewis is included.

To the Membership:

1965 was another successful year for our Society. My job as your President was an easy one due to having such fine assistance from all of the officers and members. I will briefly list our accomplishments:

We set up a budget at the first of the year for the first time and we stayed within it. Over-all expenses were \$40.00 less and income was \$73.00 more than expected. 266 people paid dues in 1965. We had five honorary members, which brought membership to 271. Of course, many of the memberships represent two persons and some are Libraries and Genealogical Societies.

The Treasurer, Mrs. Sullivan Padgitt, did a fine job. We started off the year with \$590.58 on hand; total receipts were \$2104.18; total expenses were \$1836.70; the balance on hand on 1 January 1966 was \$858.06.

Mrs, Margaret Pratt did a commendable job of arranging programs and our llth annual Genealogical Institute & Workshop, Mrs, Charles Embry, Genealogical Reference Librarian at the Tennessee State Library & Archives, was the principal speaker at the Workshop.

The Quatterly, under the able editorship of Mrs. Barry Joseph Morris, had another successful year. Sales of past Quatterlies and our Genealogical Handbook continued at a brisk pace, which speaks well for their lasting usefulness.

The Society sponsored its first annual Book Award Contest and Mr. J. Ray Andrews was the winner of the single award made by the Judges.

We adopted a new set of By-Laws and for the first time published a Year Book.

Letters were sent to three Dallas newspapers requesting a genealogical column. Copies of this letter were sent to many patriotic societies in Dallas. To date, we have little to show for this effort, but perhaps we have at least planted the seed. A letter was also sent during the year to the County Judge putting in a favorable word for keeping the old Dallas Courthouse. This effort, although certainly not due to our one letter, was successful; the building is to be continued in use.

Mr. William M. Pritchett, our Communications Vice President, performed a real service in publishing a limited edition of families being searched by our members.

During the past year, we were saddened by the loss of six members or former members. These were: Mrs. George F. Carlisle, one of our founding members:

Mrs. George S. Mitchell, Sr.; Mrs. Birdie Stone Fenlaw; Mrs. Lennie Wright Barrett, one of our Directors; Mrs. William M. Beck; and Mrs. George A. Brewer, Sr. Money for the purchase of books in their memory was given to the Dallas Public Library.

Many other additions were made to the Texas, Local History & Genealogical Department of the Dallas Public Library, which rounded out another fine year under the supervision of Mrs. Lucile Boykin, one of our Directors.

I would be amiss not to also recognize the fine efforts of Mr. Hastings Harrison, Executive Vice President; Mrs. D. R. Sellingsloh, the Membership Vice President; Mrs. Frances Lutrell, Recording Secretary; and Mrs. C. A. Brewer, Corresponding Secretary, for ably carrying out the duties of their offices. The back-up upport given by the Board Members (not mentioned above) -- Mr. Victor Gilman, Mr. Joe Latimer, Mr. John Plath Green, and Mrs. Henry O. Jones -- was much appreciated.

We are looking forward to another fine year, but to make it successful, we need the wholehearted support of all members. Please step forward when you are called on by one of our officers to assist.
