President's Annual Report

It has been my pleasure to serve as President of your Society this past year. Thank you for your co-operation and help. I would also like to thank the members of my Board for the excellent job they have done. Without their able assistance and willingness to do their job, I could not have done mine.

THE GENERAL INDEX TO PENSION FILES 1861-1934, containing 544 rolls of microfilm, was chosen as our project this year. By the time you receive this Quarterly, the project will be complete.

THE LONE STAR STATE, MEMORIAL AND BIOGRAPHICAL HISTORY OF DALLAS COUNTY, TEXAS has been made available on microfilm. This history was reprinted in 1977 by Local History and Genealogy. The book is no longer in print.

The last two years of THE QUARTERLY, 1982 and 1983, have been microfilmed and added to reel 3. ALL issues 1955-1983 are available on microfilm.

THE GUIDE TO THE QUARTERLY 1955-1982 was published this year. This is a guide to titles of articles that have appeared in THE QUARTERLY. All articles were placed in categories in alphabetical order.

We have advertised and sold our publications at the Beginners Workshop and the Annual Workshop. Our books and forms are available in the Genealogy Section of the Library. Many members have helped with the packaging and printing of labels for these forms. We have agreements with Frances Ingmire and Weldon Hudson to sell our publications and LONE STAR STATE microfilm. They can not sell the publications and microfilm for more or less than we do. This will give us wider coverage for our publications.

A Beginners Workshop was held in November, staffed by members of the Board. Our Annual Workshop in May featured Dr. Mary Quinlivan speaking on Religion in Colonial America. Both of these workshops were very well received by our members and others.

A new award certificate for the Annual Book Award was designed for the Society. It features the logo of the Society in shadow over the wording. The certificate is very distinctive and I am sure will be displayed proudly by the recipients.

On 1 July 1983 we had 481 members, and on 24 May 1984 our membership was 513, giving us an overall increase of 32 members. A Membership book listing members names, addresses, phone numbers and surnames of interest was published this year.

The Society has received many, many inquiries regarding our publications, research, membership and various other topics, and all have been answered.

The Society has issued nine Newsletters this year consisting of more than 7,200 sheets of information. These had to have labels placed on them, bundled according to zip code, and taken to the Bulk Mail Center. Not only were the Newsletters done this way, but the same procedure was followed for the DALLAS QUARTERLY and the MEMBERSHIP book.

This year we have continued adding to our Exchange of Quarterlies and Publications with other Genealogical

Societies. We have limited our list to 100, so far we have more than 80. These exchanges are placed in the Genealogy Section and add to their periodical publications.

This year besides the Exchange Quarterlies, Books received for review in THE DALLAS QUARTERLY, a \$100 Memorial for Deceased members, and a \$100 gift in honor of Mrs. Lillian Bradshaw, for her many years of service with the Dallas Public Library, we gave \$3,000 to the Genealogy Section as our Annual Gift in memory of John Plath Green, Charter Member and Founding President of Local History and Genealogy, now Dallas Genealogical Society. We also gave 3 rolls of microfilm of GENERAL INDEX TO PENSION FILES 1861-1934. Although our policy is to give one memorial for all deceased members, we felt that Mr. Green was very special, since he was so instrumental in the founding of our Society. These gifts to the Library by your Society do not include the gifts toward the microfilm project that went through DGS and the many donations that you have given directly to the Library.

DGS had budgeted income of \$10,350 for the past year. The actual income was \$10,338. The budgeted expenses for the same period were \$9,475 with actual expenses of \$9,213. The actual net income was \$4,124. The beginning balance in all accounts was \$8,761, and the ending balance in all accounts is \$9,343, after the donation to the Library's Genealogy Section.

As you can see, this has been a very busy and exciting year for the Board and Membership. Thank you all for making it so successful.



 The Committee of arrangements to prepare for the holding of the camp meeting at White Rock met at the camp grounds on July 30" 1912, and after hearing reports and full discussion it appeared to the com. that there were not campers enough who contemplate camping to hold the meeting, that the meeting at Epworth has taken a great many of our young people away at the time of the meeting, and that the excursion to Colorado and the Yellow Stone Park will take from us a number of our ministers, and further that the ministers of local charges were not inclined to help and hence it was thought best not to attempt to have the meeting this year.

[From the Editor: Can't you feel the disappointment and frustration that must have been theirs at the time of the writing of this last message! HOWEVER, with the White Rock Camp Meeting papers, there was also a copy of a hand-bill as follows]:

p. 39: Ear Mark was granted Perry DAKAN 16 Mar 1848, a crop off the right ear with underbit in the left ear; the mark for cattle, sheep, goats & hogs. Witness to signature Wm. M. COCHRAN, CCC CD TX. Recorded 16 Mar 1848.

p. 39: Charles G. NEWTON was granted an Ear Mark 25 Mar 1848. It was a smooth crop off right ear and an upper slope off left ear branded with letter "N". Recorded 26 Mar 1848.

p. 39: Ear mark was granted Samuel G. NEWTON on 25 March 1848, for cattle, sheep, hogs & goats, which was an under-half crop off of each ear and branded with a PUCHER, thus (small drawing of brand shown). Witness to signature was Wm. M. COCHRAN, recorded 26 March 1848.

p. 39: Balis EDENS & Ruth Ann EDENS, his wife, of Anderson Co TX deeded 169 acres to Samuel G. NEWTON of Dallas Co TX on 13 March 1848. Land in Dallas Co survey made and patented in name of Crawford GRIGSBY, #27, along Cedar Springs Branch west corner of James A. SYLVESTER survey #25, land held in fee simple as heirs of the Estate of Crawford GRIGSBY, dec'd. Wm. JONES, Notary Public, examined Balis EDENS & wife separately. Deed recorded 7 April 1848, by Wm. M. COCHRAN.

p. 40: Acknowledgment of deed by Balis EDENS & wife, Ruth Ann EDENS, of Dallas Co TX, dated 22 Mar 1848, was made after separate examination of Ruth Ann EDENS before Wm. JONES, Notary Public, Anderson Co TX.

p. 40: Samuel G. NEWTON of Dallas Co TX deeded 160 acres of land on the Trinity River near the 640 acre survey of Crawford GRIGSBY, to Jefferson TILLY of Dallas Co TX for \$160 on 10 April 1848, signature of S. G. NEWTON was witnessed by J. B. HILBERT and Henderson COUCH. Recorded 10 April 1848.

p. 41: \$5000 Bond for Rowland HUITT as security for performance of duties of Sheriff granted to the Governor of Texas on 19 Feb 1848 by signatures of Rowland HUITT, S. G. NEWTON, R. J. WEST, Henderson COUCH and Joel WALKER.

p. 41: Oath of Office as Sheriff of Dallas County, TX was conferred by John THOMAS, Chief Justice of Dallas Co TX on 19 Feb 1848 to Rowland HUITT, of Dallas County. Instrument of Oath was recorded 10 April 1848, Wm. M. COCHRAN, Clk. Co Ct Dallas Co, TX.

p. 42: Bond was made by John B. HIBBERT of Dallas County, TX in favor of Governor of Texas for \$500. as security for performance of John B. HIBBERT as Constable of Precinct Number One, County of Dallas, State of Texas. Bond was signed by John B. HIBBERT, as well as S. G. NEWTON, Tandy BAILEY & Anthony BLEDSOE, who signed as security on 11 Mar 1848. Instrument was for bond as well as for Oath of office. Oath was taken by John B. HIBBERT before John THOMAS of Dallas Co TX. Recorded on 13 April 1848.

p. 42 & 43: Instrument is for Oath & Notary Bond, applied for by Charles H. DURGIN, of Dallas Co TX made in favor of Governor George T. WOOD for \$2,000 on 22 Mar 1848. Securities on Bond: John N. BRYAN and John C. McCOY. Oath was sworn before John THOMAS of Dallas Co TX. Recorded on 17 April 1848.

p. 43: Ear Mark was granted Agnes TUCKER 18 Apr 1848 as mark for cattle, sheep, goats, hogs, etc., and was a smooth crop and a swallow fork in right ear. Attested by Wm. M. COCHRAN, County Clk. and by Jno. C. McCOY, Deputy.

p. 43: S. G. NEWTON of Dallas Co TX deeds Henderson COUCH, also of Dallas Co TX 58 acres of land which is part of the Cedar Springs tract, for a consideration of \$58. Witnesses to S. G. NEWTON signature on 10 Apr 1848 were Rowland HUITT and Jefferson TILLY; J. N. BRYAN signed as Notary Public and it was recorded by Wm. M. COCHRAN, Clk. Co Ct. Dallas Co TX.

p. 44: Deed for 320 acres of land was given by B. J. CHAMBERLANE to William LAVENDER for a consideration of \$320 on 15 Jan 1848. Land partly in Dallas Co and part in Navarro Co on Pleasant Run Creek, a branch of the Trinity River. Tract starts at north corner of a survey in name of R. BROTHERTON, contains the 320 acres originally granted to David GARNER by the Republic of Texas by Letters Patent. Recorded in Dallas Co Book A, Page 43. Grantor's name is given both as "Chamberlane" and "Chambers" in deed. He signs as B. J. CHAMBERS and witnesses are A. G. WALKER and Pleasant TAYLOR.

p. 45: Affidavit given by Albert G. WALKER 24 Apr 1848, which is a sworn statement by him as witness to deed. Affidavit was sworn before J. N. BRYAN, Notary Public, and recorded by Wm. M. COCHRAN, Clk Co Ct Dallas Co TX, 24 Apr 1848.

p. 45: Transfer of Certificate for 320 acres of land granted by Board of Land Commissioners of Lamar County, Republic of Texas to Pleasant WITT also of Lamar County, Republic of Texas on 3 Mar 1845. WITT had resided in the Republic of Texas three years and had performed the duties of a citizen and was awarded Certificate No. 120 on 6 Dec 1841. Signed by Wm. M. CRISP, Chief Justice & ex officio P.L.B., Coms. Isaac I. NOWELL, Associate and Jno. T. HARMON, Associate. Witness was John R. CRADDOCK, CLK.

p. 45: Sale of Certificate granted Pleasant WITT by Republic of Texas, and representing 320 acres in Lamar Co. TX. was sold to Alexander PERRY for \$80 on 13 May 1848. Signature of Pleasant WITT was not witnessed, but it was acknowledged and recorded on the day of sale, 13 May 1848.

p. 46: A Guaranty Bond for \$500 that William GRIGSBY of Anderson Co TX will sell 162 acres of land to William M.

COCHRAN of Dallas Co TX. The parcel of land in Dallas County being a part of a 1,000 acre survey made to Wm. GRIGSBY as Executor of Crawford GRIGSBY from Balis EDENS as Administrator of John GRIGSBY, dec'd, and is that part of the survey falling to William GRIGSBY known as Lot 3. Accompanied by sworn statement of W. W. CONOVER that William GRIGSBY did sign bond. William GRIGSBY's signature was witnessed by O. W. KNIGHT and W. W. CONOVER on 14 Dec 1847. Acknowledged 13 May 1848 and Recorded 17 May 1848.

p. 47: An Ear Mark instrument, wherein Joseph B. McDERMITT was issued ear mark for cattle, hogs and sheep, etc. An under half crop off each ear and an under bit in the right ear and cattle branded with the figures "2". Signed 19 May 1848 and Recorded 19 May 1848.

p. 47: John C. McCOY was granted an Ear Mark for cattle, hogs, sheep, etc. on 19 May 1848. The Ear Mark was a swallowfork in the right ear and an under half crop in the left ear. Recorded on 19 May 1848.

p. 47: Title Bond in which C. G. COLE acknowledges obligation to make a deed of conveyance in fee simple to Perry DAKAN for 47 1/2 acres of land when COLE receives a Patent from Government on said land. The Patent covers tract on which COLE then lived which he bought from J. ELLIOTT and James M. COLE in Dallas County, TX and which was part of Section No. 20 in Township One North, Range One East. The consideration for this land will be \$500 Title Bond was signed by C. G. COLE 8 May 1848, witnesses were Ben MERRELL & John L. PULLIAM. Acknowledged and Recorded on 19 May 1848.

p. 48: This Deed made by Martin GLOVER, of Bowie Co., TX. Administrator for the Estate of Valentine M. SUBLETT, dec'd., conveying 2302 acres of land to Levi M. RICE, Edward H. TARRANT and Henry D. MASON for a consideration of \$523.70 1/2 (Five hundred, twenty-three dollars, seventy and one-half cents). The land was on West Side of Trinity River in Robertson County, Republic of Texas and was surveyed by virtue of Headright Certificate of Live DIXON, granted by B.L.C., of San Augustine Co., dated 22 June 1838, No. 621, adjoining survey of Utherich. This land was sold under order of Probate Court of Bowie County, Republic of Texas to settle debts of Estate of Valentine M. SUBLETT. Deed was signed by Martin GLOVER, Administrator of the Estate of Valentine M. SUBLETT on 1 Oct. 1844 in presence of Hezekah BAYLESS and John H. LEWIS, witnesses, was Acknowledged 2 Feb 1846 and Recorded 23 May 1848. It had also been recorded in Boston, Bowie County, Book B, Pages 338 and 339 on 28 Feb 1846.

p. 49 not shown.

p. 50: Perry DAKAN of Dallas Co., Texas gave bond to Albert G. COLLINS, also of Dallas Co., Texas, involving 320 acres of land bought for \$1,280; \$640 of this was in notes and cash as follows: \$75 in hand at time of sale, \$100 plus interest at 10% due 1 Mar 1849; \$188 plus interest

at 10% due 1 Mar 1840, and \$189 plus interest at 10% due 1 Mar 1851. Land involved was on White Rock Creek Dallas County, TX. Bond was to be void on receipt of all payments. Signed by Perry DAKAN on 29 May 1848, in presence of John C. McCOY and Wm. M. COCHRAN. Acknowledged on 29 May 1848 and Recorded 30 May 1848.

p. 51: Samuel G. NEWTON of Dallas Co., TX gave mortgage to John HENRY and Edward CUNNINGHAM, of Van Buren, County of Crawford, State of Arkansas 13 May 1848 for 160 acres of land for which he paid \$1.00 and \$1800 mortgage, as payment. Out of a 640 acre survey, patented to Crawford GRIGSBY, No. 27, to west corner James A. SYLVESTER, 160 acre for County Site, No. 25, Party of 1st Part pays to 2nd Parties total of \$1800 plus interest at 6%. Refers to Bond executed by Jefferson TILLY, 169 + 160 acres. S. G. NEWTON signed in presence of Rowland HUITT and J. L. SAMSON on 13 May 1848. Mortgage was recorded 30 May 1848. Remarks on instrument: "Mortgage satisfied by Deed for same. S/HENRY & CUNNINGHAM, per Thomas H. JOHNSON, Atty."

p. 52 not shown.

p. 53: Nancy Caroline COOKE, Legal Representative for Wilford W. COOKE, dec'd. gave Transfer Colony Claim on 10 Jan. 1848 to Thomas L. CHENOWITH for a consideration of \$125 in which she authorizes Thomas L. CHENOWITH to demand and receive Deed from W. S. PETERS and others, his associates or legal representatives, in his own name, to land described as follows: W. Half of Section 13, Twn. 2, N. Range, One W. being the Headright Claim due Wilford W. COOKE, dec'd. as an Emigrant to W. S. PETERS and Others' Colony, County of Dallas, Texas. (Refers also to Probate Records.) Signed by Nancy Caroline Cooke on 10 Jan 1848 in presence of Edward W. CLARK and Thomas KEENAN, and Recorded on 12 June 1848.

p. 54: Franklin J. KERFOOT and wife, Harriet E. gave to John O. TRUEHEART of Galveston, TX a Power of Attorney, which instrument was signed 18 Nov 1847 in presence of Treadwell SMITH, J.P. and Jacob ISLER, J.P. County of Clarke, Virginia, and filed in Dallas Co TX 17 June 1847. Acknowledged in Book. A, Page 149. Recorded in Dallas Co TX 19 June 1847. This Power of Attorney gave John O. TRUEHEART authority to sell to Samuel SLOANE a parcel of land on Five Mile Creek, about 8 miles from Trinity River, part of a larger tract Patented to James COLE, 320 acres which were conveyed by COLE to BEATTY and WEBB, fallen to Harriet E. KERFOOT, as one of heirs of WEBB, dec'd.

p. 55: Deed by Franklin J. KERFOOT and Harriet E. KERFOOT, probably of Virginia, conveying to Samuel SLOAN 320 acres for a consideration of \$320 deeded 16 May 1848. This was 1/2 of 640 acres Patented to James COLE 20 March 1844, and situated in Robertson Co TX near the Trinity River, known as Survey No. 10, and sold by John O. TRUEHEART, Special Attorney in Fact. Harriet E. WEBB was sister and only surviving heir of David H. WEBB, dec'd.

p. 56: James B. BRYAN of Town of Dallas, gave Margaret BRYAN, also of Dallas, for consideration of \$1.00, a deed to Lots #6 and #7 in Blk #1 in the Town of Dallas. Signed on 16 June 1848 by James B. BRYAN in presence of Charles H. DURGIN, Notary Public, Dallas County, and William M. COCHRAN, Clk. Circuit Court, Dallas Co Texas. Recorded 19 June 1848.

p. 57: Perry DAKAN of Dallas, Texas, deeded to Gabriel B. KNIGHT, also of Dallas, Texas, 320 acres for \$400 on 22 June 1848. This land was part of a survey made and Patented in the name of Clarence A. LOVEJOY, No. 8, lying on White Rock Creek, also surveyed by A. G. WALKER 15 May 1848. Perry DAKAN signed deed in presence of James ARMSTRONG, F. W. DUNAWAY and William M. COCHRAN, Clk. Co. Ct., Dallas, TX. Recorded 23 June 1848.

p. 58: James A. SMITH and wife Ann SMITH, of Dallas Co TX deeded 300 acres to Gabriel B. KNIGHT, also of Dallas Co TX for \$300. This was a parcel of land on the Elm Fork of the Trinity River known as part of the Miles BENNETT's headright, Survey No. 29. Deed signed by James A. SMITH, and wife, Ann SMITH, who signed with an X, Her Mark, on 27 June 1848, in presence of John THOMAS and H. A. THOMAS and Notary Public Charles DURGIN. Recorded 28 June 1848.

p. 59: G. B. KNIGHT of Dallas, TX. deeded 200 acres to Perry DAKAN also of Dallas, TX for \$400 on 24 June 1848. This land was part of the 1476 acre survey Patented to Miles H. BENNETT, by the Republic of Texas and lying on the Elm Fork of the Trinity River, the same having been transferred from Miles H. BENNETT to James A. SMITH and by said SMITH to Gabriel B. KNIGHT and by said KNIGHT to Perry DAKAN, also surveyed by A. G. WALKER on 28 April 1848. Deed signed by Gabriel B. KNIGHT in presence of O. W. KNIGHT, Thomas C. WILLIAMS and William M. COCHRAN, Clk. Co. Ct., Dallas Co TX. Recorded 29 June 1848.

p. 60: George A. SUBLETT of Rutherford Co Tennessee, who holds written Power of Attorney from Phillip A. SUBLETT of San Augustine, TX. selling to Jefferson WEATHERFORD of Dallas, Texas, 1280 acres of land for \$398 5 July 1848. The Land Certificate No. 194 was issued to Henry GRIMES and was first filed in 1842 and is the S. E. Corner of WARFIELD's tract, NW corner of J. ROWLAND's tract, NE on R. SLOANS Line, back to Trinity River. George A. SUBLETT signed for P. A. SUBLETT in presence of Jones GREEN & Thomas M. ELLIS. Recorded 11 July 1848 at 4 P.M.

p. 61: Balis EDENS & wife, Ruth Ann EDENS, Anderson Co TX deeded 177 acres to Daniel MURRAY for \$177 9 Feb 1848. This land is part of the headright granted John GRIGSBY and is the portion of the 1000 acre tract belonging to heirs of Crawford GRIGSBY, dec'd that fell to the share of Ruth Ann Edens. Deed signed in presence of William JONES, Notary Public, Anderson Co TX & William M. COCHRAN, Clk. Co. Ct., Dallas, TX.

B O O K R E V I E W S

Here are two new publications (one book, one quarterly). They were not donated to the Dallas Library, but were selected for reviewing because of their value to all researchers.

AN INDEX TO SOME OF THE BIBLES AND FAMILY RECORDS OF THE UNITED STATES, VOL. II. E. K. Kirkham, 1984, 8 1/2"x 11", softbound, 104 pages. Order from: Everton Publishers, Inc., P. O. Box 368, Logan, Utah 84321, \$15.50.

This is an index to 45,500 records that were sent from D.A.R. chapters around the country to the National D.A.R. Library in Washington, D.C. Like the first volume, An Index To Some of The Family Records of The South, the surnames are listed by states, but this is an ambiguous categorization, for it does not mean that the whole family lived in that state. When this reviewer telephoned E. K. Kirkham about this geographical labeling, he cautioned that, "one family member could have resided in that state, but the other ten could have migrated anywhere in the United States". Following each surname is a set of numbers (frequently, several sets) that correspond to a roll of L.D.S. microfilm, and these rolls are available through the local L.D.S. Libraries.

SOUTHERN GENEALOGICAL INDEX. Vol. I #1, May 1984, 8 1/2" x 11", 46 pages. Editor: James L. Douthat. Order from: Mountain Press, 2504 Kell Road, Signal Mountain, Tennessee 37377. Published quarterly, \$15. per year.

This quarterly deals with family research in the southern states, but also includes the border states of Missouri, Ohio, West Virginia and Maryland.

The first half of this index contains titles and descriptions of articles abstracted from 71 journals and quarterlies which were published between October 1983 and December 1983. One of the extras provided by this index is information on specific counties which has been published within quarterlies from many other distant states. Some of the examples from this issue are:

- "TX, Burnet Co.- Cemeteries in Pleasant Valley" published in Utah quarterly,
- "TX, Rusk Co.- Confederate Soldiers" published in Louisiana quarterly,
- "S. Carolina - Land Grants, Feb. 1770" published in Louisiana quarterly,
- "MS, Harrison Co.- Marriages 1879-1885" published in Georgia quarterly.

The second half of this quarterly contains book reviews and a surname index. Using the same procedure as the first part of the quarterly, this part contains articles about families, abstracted from 71 journals and quarterlies.

This index is not going to replace Index To Genealogical Periodicals, but it fills a definite need for researchers with southern lines. To the editor's credit is the reminder to use a SASE when contacting genealogical societies; and also, the limited advertising. Clear, black print and wide margins make this a pleasure to use.

GENEALOGICAL QUERY INDEX. Vol. I #1, 8 1/2"x 11", 66 pages. Order from: Taproots Publishers, P.O. Box 15153, Dallas TX 75201. \$16.00 for 4 issues, \$4.50 for a single issue, if you subscribe, you will be credited for your \$4.50.

Here is an index that lists all surnames appearing in query columns from more than 106 recently published historical society journals, genealogical society quarterlies, and family association newsletters. (However, it does not include the Genealogical Helper or the Family Puzzler). The surnames in this first issue were abstracted from queries in periodicals that were published in early 1983. The editor explains that this time lag is necessary if he is to abstract from many publications.

This includes enough information for easy identification of ancestors. It is set up by surname, followed by the given name, and the date of the event (birth, death, etc.). Also included are the geographical location of the ancestor and the name of the publication that the query appeared in. An added service from the editor: researchers may request a xerox copy of the original query for \$1.00.

MONTAGUE COUNTY, TEXAS, MARRIAGE BOOKS B AND C, 1879 - 1888. Navena H. Troxel, 1983, 8 1/2"x11", softbound, 105 pages. Order from: Navena Hembree Troxel, Rt. 2, Box 79, Gore, OK 74435. \$12.00, OK residents add 2% sales tax.

Once again, Vee Troxel has published an informative and useful book. This volume includes the marriages from Book B and C (including the ministers and witnesses) plus several marriages performed in the Chickasaw Nation, Indian Territory.

The author has been careful to record discrepancies. One example of this: "this marriage is listed as 22 Dec. 1885, but license was issued 13 Dec. 1884 and filed May 1885".(p.50) There are three indexes: surnames of the grooms, surnames of the brides, and surnames of the witnesses and the ministers. Each appears to be complete. A neat book but quality of printing varies.

KIOWA CEMETERY. Leila Ford Evett, 1983, 8 1/2"x11", softbound, 123 pages. Order from: Leila F. Evett, 1312 N. Post Rd., Oklahoma City, OK 73130. \$18.50.

Researchers of Roger Mills County, OK, here is the book that will help you with your early pioneer lines - some of the people buried in this cemetery were born before 1850.

The author has listed the inscriptions found on the markers and followed this with a short family history on each surname. This latter part was only possible by the author's contacting families whose descendants lived here, by researching old newspapers, and by checking records of two funeral homes. The last part of the book is an index which appears to be complete and exact.

Included are two bonuses: there are four maps of the area, and all surnames throughout the text are in capital letters. (If the researcher finds the price a bit higher than expected, the author states that the money from the sale of the books goes into a trust fund which maintains the Kiowa cemetery), - and documentation for the trust fund is published in the book!

In 1882 Hamilton Child compiled a Gazetteer for Addison County, VT. Now, C. D. Townsend has made it a doubly useful tool by indexing the text portion of the book. This index is arranged alphabetically and includes "Data such as occupation, residence, when men or women arrived in town.... Parentage has been given where possible and families have been put together when it appeared correct." (p.1)

Because it is arranged alphabetically, an index did not seem necessary, but the researcher will want to scan each page for the hidden names. Two examples of this:

"Goodrich, Stephen m. 1812 (the) Widow of Amos Strong & Benj. Smalley",....and, "Sanford, Clark d. 1853 ae 91 (years) Orwell, VT Wife Rebecca Conkey, 2nd Wife Lucinda Bascom. Had W. R. (child)".

Researchers, be sure to check the Addendum on p. 74 "... for names that were missed in the first indexing of the book".

Here is another index by C. D. Townsend. It is set up in the same manner as the preceding book - even the addendum.

MY CROSS AND HAND FAMILIES, (AND MY BEEMAN, HAMRICK, JOHNSON, PAGE, POOLE, VANCE, WELLS, WILLIAMSON AND WOODWARD FAMILIES). Jeanne H. Henry, 1977, 8 1/2"x11", softbound, 286 pages. Order from: Southern Genealogical Services, 5913 Maysville Rd., New Market, AL 35761. \$20.00, Alabama residents, please add 4% sales tax.

The author begins this book with a preface; and to use this book, it is necessary to read this page, especially for the method of numbering generations and footnote. The remainder of the book is divided into chapters with each chapter covering one of the families listed in the title. The longest chapter, (70 pages) deals with the family of John Hand, born 1793-1795, in South Carolina. All families appear to be of southern origin from North Carolina, Alabama, Mississippi and Georgia, except Vance, Johnson and Cross which began in Europe and migrated to southern states. Within each family, several lines are traced to the seventh generation.

The numbering system, frequent indentations, and paragraphing make the families difficult to link at first glance, but fortunately, there are several abbreviated group sheets following each chapter. Ancestor charts would have been helpful also.

The author is to be complimented on her honesty in questioning family lore and fragmented references. There is no guess work here. Her facts and dates are always documented by court house records, censuses, military records, etc.; and detailed footnotes offer helpful explanations. She writes in a conversational style, the print is clear, the lines are double spaced.

The last section of the book is a 29 page every-name

index, with over 3,000 names listed. Some of the other families included are: Aiken, Cashion, Ledlow, Nobles, and Tucker.

Copied from an old newspaper clipping. (Dallas, Texas)
"COOPER, - MRS. JOHN L. COOPER, the subject of this sketch, departed this life at her daughter's home in Dallas a few days ago. She was the mother of Mrs. John L. Henry, of Dallas, and in this daughter's delightfully happy home, the good mother spent her last days. An unusually large concourse of friends assembled at the funeral, to pay their last respects of kindness and love to the remains of the beloved dead, and to mingle their tenderest tokens of sympathy with the bereaved family. Mrs. Cooper was married in another state, in 1835, to Mr. Henry Downs Jamison, and several children blessed this happy union. Death came at last to rob her of her noble husband, and for years thereafter she walked life's pilgrimage alone. Again she was united in marriage to Mr. John L., Cooper, with whom she walked life's way for many years, when again Death's messenger left her in widowhood. Thereafter, she lived with her children, to the advanced age of 78 years, when, full of years and good deeds, she was gathered unto the eternal home above. She was ill for only a few days, and her illness was not considered serious, until just a few hours before she died. Death's coming, however, did not find her unprepared. Life a ripe sheaf, she was only waiting for the great husbandman to gather her into the heavenly treasure house. Rarely has it ever been given to the writer to know one so matured in Christian character, one so trustful and happy in the Christian life. At the early age of 14 years, she gave her heart to Jesus, and for life's remaining 64 years, she was ever found following in His steps. Her whole life was a daily 'looking unto Jesus.' In every condition of life, the Lord was looked unto for His guidance and blessing. If some journey was to be taken by a loved one, if some difficult duty was to be met, it was all committed to the Heavenly Father by the trustful mother. If she must needs bear sorrow, and if trouble lowered about her loved ones, then she clung the more tenderly to the cross, and bound to her heart the great promise, that 'all things work together for good to them that love the Lord.' On the morning before her death, the daughter read to the mother selections from God's Word as she was daily wont to do. This passage from Isaiah specially rejoiced the mother's heart: 'Fear thou not, for

I am with thee; be not dismayed; for I am thy God; I will strengthen thee, yea, I will help thee; yea, I will uphold thee with the right hand of my righteousness'. The reading of this passage called forth the triumphant rejoicings of the mother's heart. Said she: 'God's Word is true, my heart has known His unfailing help through all the years, and His presence and help become more real and precious as I near the end of life's journey'. And thus rejoicing and testifying of the grace of Jesus, the mother's soul returned to the bosom of God. What a contrast this triumphant faith, in the dying hour, with the blindness of that doubt that walls out in death: 'I am going I know not whither.' The funeral services were held at Judge Henry's home at 513 Gaston Avenue. Pastor George W. Truett read selections from God's Word and made remarks thereon. Touching prayers were offered by Rev. Dr. Anderson and Gen. Gano. Beautiful songs the mother loved in life were sung by friendly voices. And then the funeral cortege proceeded to Greenwood Cemetery, where was laid the body of the beloved dead, there to await the resurrection, in the last great day. Only three children were present, Mrs. Henry and the two manly sons from St. Louis, Messrs. Samuel T. and Dorsey A. Jamison. Two other sons, Prof. R. D. Jamison of Nashville, Tennessee, and James H. Jamison, of Cliftonville, Mississippi, and a daughter, Mrs. Lou H. Hall, of Brooksville, Mississippi, could not be present. Thus passed away one of earth's noblest women. Faithful always to duty, trustful ever in God, such lives are the very salt of the earth. She is not dead! Death never comes to souls like hers! For her, death has been abolished, and to her, light and immortality have come through the gospel of the Lord Jesus Christ! God bless her precious memory."

IN MEMORIAM

(Copied from an old newspaper clipping)

"Departed from this life, October 30, 1897, at Dallas, Texas, Mrs. Sarah Woodlief Cooper, relict of John L. Cooper and daughter of William Thomas, of Nottoway County, Virginia, and Eliza Bass, his wife, of Brunswick County, Virginia. In the early days the Thomas family removed to Tennessee where, with the Marshalls and a few other of like tastes, the children made lasting friendships and received their secular education from the same dear old man, Squire Marshall, who gathered them and their elders about him in the rustic school house upon the Sabbath day for scripture lessons. Mrs. Cooper came of patriotic stock, having besides other relatives in the conflict, six uncles on the Thomas side and one on her mother's, Frederick Bass, all of whom fought during the entire period of the Revolution, returning safe to their homes at the close. She was first married in 1835, at the age of sixteen, to Henry Downs Jamison, a descendant of a Revolutionary hero, Col. William Downs, of South Carolina, and again in 1876 to Mr. John L. Cooper. Two of her sons reside in St. Louis, Missouri, and other children in Tennessee and Mississippi, but at the time of her death she was with her daughter, Mrs. J. L. Henry, of this city. At the last meeting of the Jane

Douglas Chapter, D.A.R., of which Mrs. Cooper was an honorary and much beloved member, the following resolutions were adopted:

WHEREAS: The Jane Douglas Chapter, Daughters of the American Revolution of Dallas, Texas, mourns the loss by death of Mrs. Sarah Woodlief Cooper, an honorary member, who literally fell asleep in her room in her daughter's home and awoke in heaven, Saturday, October 30th, 1897.

RESOLVED: That in her death, the first in our Chapter, we have lost one of our most valued members, and that we shall long miss her gentle, lovely face, on which nearly eighty years had failed to write their winters, but left only the record of fair summer days, and of a good life well spent.

RESOLVED: That we deeply sympathize with her daughter, Mrs. John L. Henry, our regent, in her great bereavement.

RESOLVED: That a copy of these minutes be entered in the Chapter records, and also that they be published in the American Monthly and Beau Monde."

The following letter dated Dallas, 12 Jan 1898 from Alf (?) Davis, is to his father. Maj. H. Cabanys at Shelby, NC. The copy of this letter was sent to the Dallas Public Library, and was put in the Vertical File. The letter copy was submitted by Margret Pearce, Dallas, and the letter is owned by Joe DePriest, Shelby, N.C.

Dear Father:

Sunday morning stormy, I got up and got a News while I sent Dennis to the P.O. and just as I was commencing to write you he came in with a letter from you which was a surprise as just five days ago I received Mothers, yet I wish they would come every day, I could enjoy them. Am glad to hear the people of Cleveland are prosperous, yet you write of Jake Borders and others being sold out. There are all ways the thriftless egotist that comes to naught after pretentions and such I think Borders has. Am very much surprised that Miss Eula Brown has not married before as she was what the world calls a beauty and dashing, I am glad has done so well. If you write send my congratulations. I was at work last Monday when the Postman brought Mother's letter. I got a man to drive my team while I read it, and it was the grandest treat I ever had as I had not heard from you for a month; in it she hoped that it would find me at work, which it did and just the hardest sort, hauling dirt in which scrapes a constant move from 6 to 12 and from 1 to 6 not a rush but a steady move. I prefer it to hauling gravel or rock on account of my teams it is not hard work for them. There are miles of streets being graded, graveled and paved with boisdark, sidewalks being concreted, water, gas and sewer pipes lain. There was about 75 teams in sight last week and at 500 men. The most of the laborers are foureners, and they make good ditchers and shovelers, but so far as citizens are a blank. But here they keep up an army of whiskey men and gamblers, where they spend their weeks work Saturday night and Sunday. Day labor is worth 1.50 cents a day. And there is I guess

between 5 and 10 thousand in town and I guess there are 1000 teams at work on the streets and still the contracts are being let. Teams get 3.00 dollars a day. Last week I put in six full days with both my teams which is 36.00 dollars, if the weather is fairly open I will make some money. When spring opens I think Will and myself will take a contract of delivering 1000 cords of boisardc to the RR and leave the city for a few months. We go to the Floyd Street methodist church to preaching to hear a young friend preach, Sam Hay who filled the east side methodist church of Paris last year. He is the most eloquent speaker I ever listen to and a very smart man. The Cumberland Presbyterians have been carrying on a protracted meeting right here at us. The celebrated evangelist Dr. Hendrix was to preach but after a few sermons was downed with Grippe which completely ousted the meeting. It is claimed that there are many cases of Grippe which may run me out of Dallas. I hear from friends in Lamar, who are well. I want to see Mr. Jennings children as bad as if they were my own (I reckon). They are the sweetest best children in the world. I have to write to Tons (?) Martin about some settlements in Lamar. I left a heap of things and accounts which I will have to attend to closely. Write often and love to you all, Alf Davis
