So, be patient! Timothy CARPENTER's signature on 4 April 1849 was made in presence of William O'GUIN and Mary J. HORD. Transaction was proven the same day by W. H. HORD and it was recorded 9 Jan 1850 by A. HARWOOD, D. C. C.

p. 237: On 21 Nov 1849 Perry DAKARR of Dallas Co TX executed a Power of Attorney in favor of Warren A. FERRIS of Dallas Co TX, granting FERRIS authority to execute a deed to a half section of land sold to Albert G. COLLINS when the notes were fully collected. This 320 acres was priced at "near \$400 in all". Acknowledged 21 Nov 1849 by J. W. SMITH. C. C. and recorded 14 Jan 1850 by A. HARWOOD, D. C. C.

p. 238: Perry DAKAN of Dallas Co TX deeded 68 acres to Stephen HEIFINGTON of Dallas Co TX on 10 Jan 1850 for \$160. Land was described: On White Rock stream, part of Survey #8. The name of Clarence A. LOVEJOY was mentioned in the deed. Warren A. FERRIS, Attorney, witnessed the signature of Perry DAKAN to this Deed, and it was acknowledged 12 Jan 1850 by J. W. SMITH, C. C. and recorded 14 Jan 1850 by A. HARWOOD, D.C.C.

p. 239: Albert G. COLLINS of Dallas Co TX signed an Instrument of Relinquishment for 68 acres, on 14 Jan 1850 in favor of Stephen HEIFINGTON of Dallas Co TX. This was Part of Survey #8, part of 320 acres purchased from Perry DAKAN. It was acknowledged and recorded 14 Jan 1850 by A. HARWOOD, D. C. C.

p. 239 - 240: On 3 Jan 1849 John N. BRYAN of Dallas Co TX gave Bond for Deed for Town Lots 3 & 4 in Block #13 Dallas, to Nancy KEEN of Dallas Co for \$100, \$20 of which was in form of a promissory note payable in 2 years from John KEEN. John N. BRYAN's signature was witnessed by Jno. W. SMITH and H. H. HALL. Transaction was acknowledged and recorded by A. HARWOOD, D. C. C. on 16 Jan 1850.

p. 240 - 241: A Bond for Title of 100 acres at the N. E. corner of Section #21 Twp. #1 of the 1st case line and range #1 of 1st meridian of Survey of Peters Colony was given by

Seincoe/Sincoe POPPLEWELL of Dallas Co TX to Heram BENNETT of Dallas Co TX for \$200 ON 14 Jan 1850, acknowledged the same day and recorded 16 Jan 1850, both by A. HARWOOD, D. C. C.

p. 241 - 243: John & Margaret HENLY/HENBY, of Anderson Co TX deeded 162 acres to Wm. P. CARDES of Dallas Co TX for \$160. Margaret C. HENLY/HENBY was widow of John GRIGSBY, Jr. She was selling land in Dallas Co, part of John GRIGSBY, Sr's Headright, John PARKENS Survey. Crawford GRIGSBY's name was also mentioned in the Deed. John & Margaret HENLY/HENBY signed deed 12 Jan 1850, John HOPELL & James M. PERRY were witnesses. Transaction acknowledged 12 Jan 1850 by James James M. PERRY, Notary Public Anderson Co and it was recorded 17 Jan 1850 by A. HARWOOD, Dallas County Clerk.

p. 243 - 244: Bond for Title of 320 acres was given by Jefferson TELLEY/TILLEY of Dallas Co Tx to Wm. BRUTON of Dallas Co TX for \$400, of which \$200 was cash received. This was West half of Section #21 of Township #1 North of 1st base line and Range #1 East of 1st Meridian of Surveys of W. S. PETERS and others commonly known as Peters Colony. Jefferson TELLEY/TILLEY gave his signature on 17 Jan 1850 and on this same day the transaction was acknowledged and recorded, both by A. HARWOOD, D. C. C.

p. 244: Bill of Sale was given by SMITH & PATTERSON, Dallas Co TX to Margaret FESTNES of Dallas Co TX for a Negro Woman named MARCELETTA, consideration was \$550. Bill of Sale was signed 19 Jan 1850 by Jno. W. SMITH & James M. PATTERSON, and was acknowledged and recorded the same day by A. HARWOOD, D. C. C.

p. 245: Hiram BENNETT of Dallas Co TX gave Bond for Title to 100 acres to Simcoe POPPLEWELL, for \$200. Land was at corner of Sect. #31, Township One N of 1st Base Line & Range One East of 1st Meridian of Surveys of Peters Colony. Hiram BENNETT's signature was given 21 Jan 1850; acknowledgment and recording were made the 21 Jan 1850 by A. HARWOOD, D. C. C.

p. 246 - 247: Deed for 200 acres was granted James ARMSTRONG by Wm. & Mary M. COX, both of Dallas Co TX for \$500. This land was on S.W. side of White Rock Creek & on Survey #20 of 1280 acres in Dallas County, beginning at South Corner of a tract of 329 acres belonging to Ellis C. THOMAS. This transaction was signed by William Cox and by Mary M. COX using "Her Mark", on 10 Jan 1850, was acknowledged 30 Jan 1850 by Chas H. DURGIN, Notary Public, D. C., and recorded on 31 Jan 1850 by A. HARWOOD, D.C.C.

p. 247 - 248: In Putnam Co Illinois was granted Power of Attorney by Elzy DOWNEY of Putnam Co Illinois to Electa/Electra BETHURAM of Dallas Co TX on 13 Nov 1849, giving Electa/Electra BETHURAM power to settle estate of Robert BETHURAM as it may apply to his wife Mary, daughter of Robert and Electa/Electra. Acknowledged 13 Nov 1849 by Nelson DURGAN, Jr., J. P. Recorded 4 Feb 1850 by A. HARWOOD, D. C. C. (John DOWNEY's name mentioned in this document.)

p. 248 - 249: On 9 Dec 1847 John N. & Margaret BRYAN Deeded Dallas Town Lots #1 & 2 in Block #23 to Elizabeth B. DURGIN, all principals of Dallas Co TX for Love & Affection & \$5. Deed was acknowledged 10 Dec 1847 by Amos CLARK and recorded 6 Dec 1850 by A. HARWOOD, D.C.C.

p. 249 - 250: This instrument was an Acknowledgment dated 11 Feb 1850 given by Margaret BRYAN of Dallas Co TX to C. H. DURGIN, and was acknowledged 11 Feb 1850 by W. H. HORD, Ch.Jus. D.C. Recorded 11 Feb 1850 by A. HARWOOD, D.C.C.

We are indebted to Helen M. LU for the following, taken from the Texas Christian Advocate, Vol. VI, No. 50, dated 19 July 1860, Page 2:

DISASTROUS FIRE

On Sunday July 8th, at about half after one o'clock, the citizens of Dallas, Dallas county, Texas, were startled with the terrible cry of fire. The flames had broken out in front of PEAK's new drug store, which almost immediately enveloped the whole house. It was a two story frame, and filled with stores of all kinds. The fire then spread to SMITH's warehouse, then to the Herald office, from which nothing but the books could be removed. The Herald office was a total loss, four presses, material of every kind, clothing, in fact everything. But as we learn from a letter received in this city from the proprietor, that the paper will again be in operation in less than six weeks, new material of every kind having been ordered. The St. Nicholas Hotel, a large three story frame building, 100 feet front, by 100 back, is totally consumed. SMITH & MURPHY's brick store burnt. SHIEK'S new warehouse and store, with entire stock of goods; the CRUTCHFIELD House and all its furniture, including the Post-office and the matter in it; WESTERN's Corner; SIMON's new building just framed; HIRSH's large storehouse with entire lot of goods; CARR's new frame building; SIMON's store and goods; NICHOLSON & FERRI's Exchange Office; THOMAS' drug store; EILLETT's storehouse and goods; MCCOY's law office and books; STACKPOLE's entire establishment; CAMTH's [possibly a typesetting error? Likely CARUTH's] storehouse and goods; FLETCHER's mercantile establishment; BIRTLE's old establishment and private residence; Mrs. BINGHAM's old residence; law office, books and papers belonging to LEONARD, MCKENZIE, CROCKETT, ADAMS, CHAPMAN, RUSSELL, HAY; and the medicine, surgical instruments and libraries of Drs. PRYOR, SPENCER, JOHNSON and THOMAS.

It was impossible to compute the exact loss, which will in all probability exceed \$300,000. All are houseless and homeless, now; it was indeed a rude awakening from last Sunday's afternoon siesta, the citizens of Dallas experienced. Many barely escaped with their lives, and clothing they happened to have on at the time. -- Houston Republican.

INCENDIARISM IN TEXAS

The suspicions aroused by the occurrence of several fires, in different places, about the time the town of Dallas was burnt, appear to have been well-founded. Dallas was burnt on Sunday the 8th -- probably by some fanatic whose motto was "the better day the better deed"; the next day the house of John J. EAKENS, one mile from Dallas, was fired; on Wednesday, the destruction of the house of E. P. NICHOLSON was attempted in like manner; on Thursday the stables, out houses, grain and vats belonging to C. MITLER [probably MILLER] was destroyed by fire. It is believed, on what seems to be good evidence, that these fires were part of a plot to devastate Northern Texas -- that the first object was to destroy arms and ammunition by fire, preparatory to the success of an insurrection on the day of election in August. Dr. PRYOR of the Dallas Herald writes under date of the 16th: "Arms have been discovered in possession of the negroes, and the whole plot revealed for a general insurrection in August." The plot is attributed to 'certain abolition preachers who were expelled from the country last year.' BLUNT and McKINNEY are among the names given. It appears also that the Indians were engaged to assist in the work of destruction. "All is confusion, excitement and distrust. There never were such times before."

The Houston Telegraph has seen a letter from Waxahachie, which gives some details of the discovery of a plot similar to the one which proved successful at Dallas. Two white men were hung on the 21st. Upwards of twenty negroes were to be hung the next week. Some half dozen other places, besides those mentioned, were attempted to be fired. Dallas, Ellis, Tarrant and Denton counties are known to have been embraced in the scheme, traces of it having been discovered in each.

All the reports that we have given may not be correct. There are others which we omit. Enough is known to warrant the citizens of the threatened and injured region in the formation of vigilance committees of the best citizens. This will doubtless prevent the procedure of the plot, and lead to the detection and punishment of some, at least, of the incendiaries. We hope the excitement will not cause the escape of the guilty, nor the injury of the innocent. [Editor's note: The article continued, of general information regarding abolition and conflicts, but nothing further regarding the Dallas area.]

Texas Christian Advocate, Vol. VI, No. 52, 2 Aug. 1860

TEXAS ITEM; Dr. PRYOR, of Dallas, writes to the editor of the State Gazette, that on the 24th of July, the three negro leaders in the intended insurrection were hung at that place. One of them acknowledged that he had set fire to the town, and after its destruction boasted that it was "only the commencement of the good work". The doctor thinks it would be impossible for the whole abolition fraternity to surprise the citizens now.
