"A correspondent of `The Galveston News' writes from Dallas:

"CROPS IN DALLAS COUNTY

"I have never seen in any county finer prospects for crops of corn, oats and cotton than we have here at this time. The wheat crop is made and generally saved; it is equal in quality to any I have ever seen, and in quantity per acre, is but very little short of the best Virginia crops. When the country is older and the wild nature is gone out of the soil, I believe the crops will full equal those of the best wheat-growing countries in the United States."

A short article from the Texas Wesleyan Banner dated 12 July, 1851, Vol. III, No. 3, contributed by Helen M. LU:

"A correspondent of `The Galveston News' writes from Dallas: "CROPS IN DALLAS COUNTY

"I have never seen in any county finer prospects for crops of corn, oats and cotton than we have here at this time. The wheat crop is made and generally saved; it is equal in quality to any I have ever seen, and in quantity per acre, is but very little short of the best Virginia crops. When the country is older and the wild nature is gone out of the soil, I believe the crops will full equal those of the best wheat-growing counties in the United States."

DALLAS COUNTY DEED BOOK BOOK "B"

p. 134: J. L. SAMSON and Stephen B. McCOMMAS gave a Quit Claim Deed to William P. CARDER for soldier's claims, on 17 Mar 1849. These six claims included two claims for land scrip, two claims for lost horses and two claims for arrearage pay, claims on behalf of C. C. CARDER & Elijah S. CARDER. J. L. SAMPSON's and Stephen B. MCCOMMAS' signature witnessed by Jno. W. SMITH Clk.C. C. & J. M. CROCKETT, D. C. Deed recorded 14 May 1849.

p. 135 & 136: W. L. BEATY gave a Deed of Trust to Samuel SLOAN et al on 5 June 1846 to ten acres on the west side of the Trinity River, between it and Five Mile Creek (being part of a Survey made for W. S. BEATY of 640 acres of land) containing 10 acres or more. Deed provided that Trustees Samuel SLOAN, Lenan and Aron OVERTON were to establish settlement, use timber to build church or churches, burial ground, school house, and preserve land where brother is buried, also if above Trustees die or fail to perform, and settlement is not established, the land shall forever remain open to public. W. L. BEATY signed in presence of P. J. PILLANS. N. P. Recorded 15 May 1849.

p. 137 & 138: On 16 May 1849 J. N. BRYAN gave bond to Smith ELKINS for \$400, of which \$100 was paid immediately and the balance was covered by a promissory note, payable when title was made for Lots number 8 in Blk number 2 in Town of Dallas, TX. J. N. BRYAN's signature was witnessed by Jno. W. SMITH & Jno. M. CROCKETT, D. C.

p. 138 (139): Fourteen hundred, seventy-six acres of land in Dallas County changed hands when Moses M. HUGHES of Navarro Co gave to John WELCH, also of Navarro Co, a deed in consideration of \$1,476. This land was part of headright survey of James HUGHES on waters of Cedar Bluff or Mountain Creek. Moses M. HUGHES' signature was witnessed 26 Mar 1849 by Wm. HAMILTON and Wm. SMITH, Notarized by S. C. CROSS and Recorded 18 May 1849.

p. 139 (140) On 31 Oct 1848, Ruth Ann EDENS received from Balis EDENS, of Anderson Co, Administrator of the John GRIGSBY Estate, a deed for 320 acres described as Lot No. 2 of GRIGSBY plat, bounded by Survey of James A. SYLVESTER. This was a release of Estate Land to Ruth Ann EDENS, as Heir. Witness to Balis EDENS' signature was James A. HARRIS and D. H. EDENS. Recorded 23 May 1849.

p. 141 (142): Five hundred acres of land, representing Lot 7 of GRIGSBY plat, was transferred by Deed to Emeline GRIGSBY on 31 Oct 1848 by Balis EDENS of Anderson Co, Administrator of Estate of John GRIGSBY, as her share of the GRIGSBY Estate. Balis EDENS: signature was witnessed by James. A. HARRIS and D. H. EDENS. Deed was recorded 23 May 1849.

p. 142 (143): Title Deed for 510 acres was made to Daniel B. GRIGSBY by Balis EDENS, of Anderson Co, Administrator of

Estate of John GRIGSBY. This land was Lot No. 3 of John GRIGSBY plat, which crosses and contains part of Turtle Creek. Balis EDENS' signature as Administrator was witnessed by James A. HARRIS and D. H. EDENS, and Deed was Recorded on 23 May 1849.

p. 144 (145): John SITTLE and Elizabeth, his wife, sold to Elias T. MYERS, all three of Dallas County, 204 acres on Duck Creek, part of League Surveyed and Patented to John SITTLE. Consideration was \$100. John SITTLE's signature and Elizabeth SITTLE's "X" (Her Mark) were witnessed by John P. WATTON, Clk. of Co Ct, Anderson Co, and Levi JIRDON. On 28 May 1849 this Deed was Recorded.

p. 145 (146): Deed for 318 acres was given by Robert SLOAN to William B. MILLER, both of Dallas County, on 24 May 1849, as Collateral Security for performance of conditions in Bond of 17 Mar 1849. Land was Survey No. 31 on Five Mile Creek, bounded by Surveys of D. MCFARLIN and C. L. HASS. Consideration for this Deed was \$640. Robert SLOAN signed in presence of Jno. C. MCCOY, and Deed was Recorded 29 May 1849. A margin note on this Deed states that above was cancelled 3 Sept. 1874 and this note was signed by Wm. B. MILLER whose signature was witnessed by A. HARWOOD.

p. 146 (147): Deed for 90 acres of Robert SLOAN Survey on the West Side of the Trinity River, given by Robert SLOAN of Dallas Co to John CONWAY, also of Dallas Co on 28 May 1849 for \$101.25. SLOAN's signature was Notarized by Jno. W. SMITH, Clk. C. C. D. C. Recorded 29 May 1849.

p. 148 (149): Robert SLOAN gave Deed to John CONWAY, both of Dallas Co for consideration of \$226.62 1/2, on 28 May 1849. This was part of survey of 1470 acres for Robert SLOAN on West Side of Trinity River. Amount of acres in this transaction was not shown. Robert SLOAN's signature was Notarized by Jno. W. SMITH, Clk. C. C. D. C. Recorded 31 May 1849.

p. 149 (150): Settler Patent of 640 acres was given by Governor Geo. T. WOOD, of City of Austin, Representing the State of Texas, to Eli SMITH, Assignee of William C. WALKER. Land was in Robertson District, Dallas Co, Survey No. 26 on Pleasant Run Creek, was Headright No. 337 of William C. WALKER and borders Surveys of James McMILLANS. This Patent was signed 19 Apr 1849, recorded on 18 June 1849. Headright was transferred from WALKER to SMITH 15 June 1848. Witness to official signature of State of Texas were G. W. SMYTH and Geo. T. WOOD, Governor.

p. 151 (150) Eli SMITH of Navarro Co TX gave Deed to Pleasant TAYLOR of Dallas Co TX for \$320. The land was Survey No. 26 on Pleasant Run Creek, a branch of the Trinity 14 miles S. by E. from Town of Dallas, by virtue of Conditional Headright Certificate \$302 issued to Wm. WALKER by Board of Land Commissioners of Washington Co on 12 Dec 1839 upon which Conditional Certificate \$37 was issued by same Board on 6 Nov 1845 and by said WALKER transferred to

Eli SMITH on 15 Jan 1848. No acreage amount was shown on this Instrument. Signed by Eli SMITH 11 June 1849, recorded on 20 June 1849.

p. 153 (152): Second Class Patent #439 of 1280 acres was issued by George T. WOOD, Governor of the State of Texas, at Austin, TX to B. J. CHAMBERS, Assignee of Martin WEST on 16 Jan 1849. This land was in Robertson District, Dallas Co TX Known as Survey #24 on Trinity River, about one mile above Pleasant Run Creek and was by virtue of WEST's conditional headright certificate #130 issued by Board of Grimes Co on 26th day of Feb 1848 and was then transferred by him to B. J. CHAMBERS on 29 April 1848. This 2nd Class Patent was signed by George T. Wood, Governor, and was recorded 2 July 1849.

p. 154 (153): On 28 May 1849 Nathaniel B. SAWYER of Dallas Co TX received 134 1/2 acres by Deed from Robert SLOAN of Dallas Co TX for which he paid \$134.25. This was part of Survey of 1476 acres made for Robert SLOAN on W side of Trinity River. Deed was recorded 27 May 1849.

p. 155 (154): Robert SLOAN deeded 90 1/4 acres to Nathaniel B. SAWYER, both of Dallas Co TX, on 28 May 1849, for \$90.25. These were also a part of the 1476 acres surveyed for Robert SLOAN and located on S & W side of Trinity River on waters thereof. Deed was recorded 30 May 1849.

p. 156 (155): Benjamin MERRILL, Assessor and Collector in Dallas Co TX sold 3070 acres to Aaron OVERTON on 18 May 1848 for \$29.50. This total was made up of \$3.09 tax due by James HUGHES, plus \$3. costs and \$23.41 overplus of tax and costs or a total of \$29.50. The 3070 acres were in Survey #6 on waters of Cedar Bluff Creek. Recorded 13 July 1849.

p. 157 (156): William Mercer SIMPSON of Nacogdoches Co TX deeded 320 acres to Morris FERRIS, for \$300 on 18 Oct 1848. The land in Dallas Co TX on E side of White Rock Creek was land on which Morris FERRIS resided. William Mercer SIMPSON's signature was witnessed by Ben MERREL as well as Servis FERRIS who signed for SIMPSON. Deed recorded 3 July 1849.

p. 159 (158): One-half of Lot #8, Blk #3 on Plat of Town of Dallas was sold by Sheriff Deed by John B. HIBBERT, Constable in Dallas, TX to Blizabeth HARTER for \$27.50 on 24 July 1849. This Deed was recorded 24 July 1849. Under remarks appeared the following: "Peter HAUGHT got a judgment against Abraham WORTH for \$28.16 against goods and chattels, land, etc. of Estate of Abraham WORTH."

p. 160 (159): Morris FERRIS and Nancy FERRIS, his wife, of Dallas Co TX deeded 320 acres to B. I. HUNTER and Lenoir HUNTER for \$700. This 320 acres in Dallas Co is on E side of White Rock Creek, being Morris FERRIS' residence. No dates were shown, but under remarks was the following: "Excepts small' berrying' place of a child and being 25 feet in every direction around the grave."

p. 161: On 24 Mar 1849 John LITTLE and Elizabeth LITTLE, his wife, of Anderson Co TX deeded 20 acres on Duck Creek in Dallas Co to William H. KEEN of Dallas Co TX for \$20. John LITTLE's signature and Elizabeth LITTLE's Mark ("X") were witnessed by John P. WALTER and Levi JORDON. Deed recorded 17 Aug 1849.

p. 163 (162): John LITTLE and wife Elizabeth LITTLE of Anderson Co TX deeded 100 acres to Henry P. TUGGLE of Dallas Co TX for \$60 on 24 Mar 1849. This land was on Duck Creek, part of League Survey patented to John LITTLE. John LITTLE's signature and Elizabeth LITTLE's mark ("X") were witnessed by John P. WALTON and Levi JORDAN. On 20 July 1849 this was recorded.

p. 165 (164): Lots 1 and 4, Blk 1 also Lot 4, Blk 10, Town of Dallas, Country of Dallas, were sold by deed by Charles H. DURGIN and wife, Elizabeth DURGIN, of Dallas Co TX to Charles M. STANLY of Cass Co TX on 10 Aug 1849 for \$1000. Charles H. DURGIN and Elizabeth DURGIN signed in presence of Nat M. BUFORD and J. C. McCOY. Recorded 16 Aug 1849. Wife's acknowledgment signed 16 Aug 1849 by W. H. HORD, Chief Justice, Dallas Co TX and Rec. 21 Aug 1849, Book 13, pages 164 and 165, J. W. SMITH, Dallas Co Clerk.

p. 165 (166): Charles N. STANLEY and Mortimer WORD of Cass Co TX deeded Lots #1 and #4, Blk #1, in Town of Dallas, TX to Charles H. DURGIN for \$100. Charles N. STANLEY's and Mortimer WORD's signatures were witnessed by Sam F. MOSLEY, P. M. GRAHAM, County Clerk, Cass Co TX, and J. K. WILLIAMS. Recorded 17 July 1848 Cass Co TX Book C, p. 193.

p. 166 - 167: A total of 1280 acres was involved in a Transfer of Land from Charles M. STANLEY and Mortimer WORD on 25 Nov 1847. Consideration was not listed. The description of the land is as follows: Parcel #1: Ctf. #28, Class 2, (orig.) granted to James W. LAKIN, Board of Land Commissioners of Cass Co State of Texas (sic) for 320 acres; Parcel #2: Land Ctf. #23, Class 4, granted to Willis D. LAKIN by the Land Commissioners of Cass Co and State of Texas (sic) for 320 acres; and Parcel #3: (Land) Certificate #285 Class 2, granted to William KELLY by the Board of Land Commissioners of Shelby Co, State of Texas (sic) for 640 acres. C. M. STANLEY's and M. WORD's signatures witnessed by Sam F. MOSELEY and J. K. WILLIAMS. Transfer was signed and recorded in Town of Jefferson, Cass Co TX and sworn to by P. M. GRAHAM, Co Clk Cass Co. Filed in Dallas Co TX 21 Aug 1849 and Recorded in Book B, pp.166-167 by J. W. SMTH, C. C. D. C.

p. 168-169: A Deed for Town Lot #4, Blk. 10 was granted by John N. BRYAN and wife, Margaret BRYAN of Dallas Co TX to Charles N. STANLEY and Charles H. DURGIN, Dallas Co TX for \$100 on 9 Dec 1847. Signatures of Grantors were witnessed by Perry DAKEN and Jno. C. McCOY, and sworn before Amos CLARK, Judge, Sixth Jud. Dist. Recorded 22 Aug 1849.

p. 169-170: John N. BRYAN acknowledges Power of Attorney vested in John BEERMAN and Charles H. DURGIN, "or either of

p. 171-172: Certificate No. 28, Class 2, granted to James W. LARKIN by the Board of Land Commissioners, Cass Co TX for 320 acres and Certificate No. 285, Class 2, granted to Wm. KELLY by the Board of Land Commissioners of Shelby Co TX for 640 acres, were transferred from Charles H. DURGIN to Charles N. STANLEY on 16 Aug 1849. There was no consideration named. SIgnature of Charles H. DURGIN was witnessed by Nat M. BURFORD and J. C. McCOY. Recorded 16 Aug 1849.

p. 173-174: Balis EDENS of Anderson Co TX, Administrator for the Estate of John GRIGSBY, deceased, deeded Town Lot #88, Survey #23 in Dallas Co TX to Elizabeth MEAD, Heir of John GRIGSBY, on 8 May 1849. Deed was signed by Balis EDENS, Admr. in presence of Cyrus H. RANDOLPH and J. S. HANKS. Notarized by James M. PERRY, Anderson Co TX. Recorded 12 July 1849 by J. W. SMITH, C.C. Dallas Co. TX.

p. 175-176: Four hundred, eighty acres was deeded by B. J. CHAMBERS of Robertson Co TX to Thomas M. ELLIS of Dallas Co TX on 27 Nov 1848 for \$275. This 480 acres on Pleasant Run Creek, a tributary of the Trinity River, was part of a 640 acre Survey for E. L. R. PATTON, granted to B. J. CHAMBERS as Assignee of James McMILLAN by Patent dated 28 Oct 1848. B. J. CHAMBERS' signature was witnessed by Patrick P. (D.?) SMITH and Middleton PERRY. Recorded 29 Aug 1849, Dallas, TW.

p. 176-177: Elizabeth MEAD of Anderson Co TX traded 491 acres in Dallas County, being her part as heir of John GRIGSBY, dec'd. for 680 acres in Anderson Co TX on Eyson J. Creek owned by Z. ELLISON of Smith Co TX.This Deed signed by Elizabeth MEAD 8 May 1849 in presence of Wm. JONES & John PORTER. Recorded Anderson Co,8 May 1849 & 30 Aug 1849 Dallas.

p. 178-179: Power of Attorney given by Benjamin KEEFER, Co of Dallas, to Isaac Nelson COOMBS on 9 April 1849. Grantor gave COOMBS authority to take charge of KEEFER's house and farm in Dallas Co, to manage and rent it, until KEEFER's return from California. Benjamin KEEFER signed in presence of Nat M. BURFORD, Jno. C. McCOY and Charles H. DURGIN, Notary Public. Instrument was recorded 31 Aug 1849 by J. W. SMTTH, Co Clk, Dallas County.

p. 180: Jesse H. KELLY, County of Dallas, for \$750. gave Bill of Sale to John W. SMITH on 18 Aug 1849 for three negro slaves, one woman named Manda, one boy named Robert and one girl Sena, the last two being children of Manda. Acknowledged and Recorded 31 Aug 1849 by J. W. SMITH, Co Clk.

p. 181: On 20 Aug 1849, for \$400. Jesse H. KELLY of Dallas

Co, sold one negro girl named Mary, twelve years old in October next, to Aaron OVERTON, Co of Dallas. Acknowledged 20 Aug 1849 and Recorded 31 Aug 1849, both in presence of J. W. SMITH, Co Clk, Dallas Co TX.

p. 182 & 183: J. Pinkney HENDERSON, of Austin, Governor of State of Texas, granted Patent #432, Vol 5 to John P. ANDERSON. This was handled by Ira ELLIS, Assignee of John P. ANDERSON, and was One League and One Labor of Land in Nacogdoches District on the East Fork of the Trinity River. Signature of J. Pinkney HENDERSON, Governor, was witnessed on July 1847, in Austin TX by Thomas W. WARD, Commissioner of G. L. Office. Patent was filed 30 Aug 1849 and recorded 4 Sept 1849 by J. W. MNITH, CO Clk, Dallas Co, TX.

p. 183 - 184: On 19 Oct 1847 Patent No. 281, Vol 6, was granted by J. Pinckney HENDERSON of Austin TX, Governor, State of Texas, to Ira ELLIS, Assignee of Theophlus THOMAS, amounting to One League and One Labor of Land in Nacogdoches District on the waters of the East Fork of the Trinity River. This Patent signed 19 Oct 1847, filed 30 Aug 1849 and Recorded 6 Sept 1849. Witness to this transaction was Thos. W. WARD, Commissioner of the G. L. Office.

p. 184 - 185: William JONES was granted Patent No. 410, Vol. 22, consisting of 640 acres situated in Nacogdoches District, known as Survey No. 3 on waters of White Rock River near the Great Military Road from Austin to Red River. Margaret C. HEWBY (?), widow of the late John GRIGSBY, Jr., remarried to John HEWBY (?) is the Grantee in this Deed. Balis EDENS, Administrator, signed this Deed in presence of John BLAIR and James A. HARRIS 25 Sept.1849,it was Acknowledged 25 Sept 1849 by John B. MALLARD, Ch. Justice & Ex Officio at Palestine, Anderson Co TX.

p. 188: A. G. WALKER, Surveyor for Dallas County, District of Nacogdoches, brought Survey Statement on 14 July 1848. Survey No. 25 in name of James A. SYLVESTER of 640 acres, and balance of Survey No. 23 in name of John GRIGSBY, of 26 Labors of Land divided by Commissioners Amon McCOMMAS and others. Names: Jas. GRIGSBY 320 acres, Ruth GRIGSBY or DEDNS 320 ACRES, Elezibeth GRIGSBY or MEDA 941 ACRES, Robt. H. GRIGSBY 530 acres, Emily GRIGSBY 500 acres, Crawford GRIGSBY 438 acres, John GRIGSBY 510 acres. William GRIGSBY 402 ACRES, Daniel B. GRIGSBY 510 acres. Signed by A. G. WALKER 14 July 1848, Filed 1 Oct 1839 and Recorded 3 Oct 1849 by J. W. SMITH, C. C.

p.189 & 190. A. G. WALKER, Deputy Surveyor, Dallas County

and District of Nacogdoches, gives a Survey Statement on 640 acres, attesting to a Resurvey of Survey #3 originally in name of William JONES, dated 20 Dec 1848 and now on application of William LATHAM, the area being on White Rock Creek and its tributary Timber Creek. A. G. WALKER signed the resurvey 30 Dec 1848 in presence of Wm. A. LAFFOON and Allen BEARD. Filed 6 Sept.1849; Recorded 9 Oct.1849, J.W.SMITH.

p. 191 & 192: By order of Anderson Co Probate Court, 438 acres was sold at Dallas Co Court House door. This was land on East side of Trinity River, in Survey No. 23 in name of John GRIGSBY, then sold by Deed Partition to Crawford GRIGSBY and marked Lot No. 6, and was now purchased by H. K. VALENTINE at 80c an acre for which he gave his note for \$350. If VALENTINE is unable to pay note the land is to be resold, and M. P. MEAD, Administrator for Estate of Crawford GRIGSBY, gave bond to this effect on 2 Oct 1849, which was witnessed by J. M. CROCKETT and J. H. COX. Bond was filed 2 Oct 1849 and Recorded 10 Oct 1849. (Name of M. P. MEAD was shown variously as M. P. MEAD and M. S. MEAD).

MILLER, of Dallas Co on 1 Sept 1849 for one black mare, one sorrel horse (each about 7 years old), one two-horse wagon, and a yoke of steers, one a dark roan and the other a white steer with black head. Consideration was \$130. Deed was proven by Wm. H. HORD, Ch. Jus. on 9 Oct 1849 and recorded the same day.

p. 194 & 195: James B. and Mary McCOMMAS of Dallas Co gave Quit Claim Indenture to William JAMES, Dallas Co. for \$20 for Survey 320 acres on waters of White Rock Creek, known as Survey No. 10 made for Arnold EVANS. Signed 28 July 1849, proven and filed 30 July 1849. Recorded 22 Oct 1849 by Jno. W. SMITH, C. C.

p. 196: William JAMES, Dallas Co, gave Quit Claim Deed for 320 acres to Andrew T. NANCY for \$10. This was for the SW half of Survey \$10 on Waters of White Rock Creek made for Arnold EVANS. Signed 30 July 1849, filed and acknowledged the same day by Jno. W. Smith. Recorded 22 Oct 1849.

p. 197: As result of recently passed laws and to secure her rights to separate and distinct interest in their acquisition, Nancy FERRIS and her husband Morris FERRIS of Dallas Co signed Deed of Record, Separate Property, on 8 Sept 1849 for the following: One wagon \$100; three yoke of work oxen \$120; one bay mare about 8 yrs old and her colt, \$50; one black horse, \$40; and 4 milk cows with their calves, \$40; property they came by, by the disposal of a tract of land. Witnesses were John CASEY and Eli FERRIS. Acknowledged 16 Oct 1849 and recorded 22 Oct 1849 by Jno. W. SMITH, C. C.

p. 198 & 199: James B. & Mary McCOMMAS of Dallas Co gave Quit Claim Deed to William JAMES of Dallas Co for Section 31, Twp. 1 N. of First Base Line and Range 2 E of First Meridian of the Survey of Peters Colony, for \$200. Signed 18 July 1849, Acknowledged 30 July 1849 and Recorded 23 Oct 1849 by J. W. SMITH, C. C.

p. 199 & 200: William JAMES gave Quit Claim to Andrew T. NANCY, both of Dallas Co for \$10 on 30 July 1849. This was SW half of Survey #10 on the waters of White Rock Creek, Survey made for Arnold EVANS and sold by tax sale to James B. MCCOMMAS who quit claimed it to Wm. JAMES. Acknowledged 30 July 1849 and recorded 31 Oct 1849 by John W. SMITH, C. C. (This seems to be the same transaction as p. 196.)

p. 200 & 201: Headright Transfer Instrument for 640 acres was given by Philip KEMMEL to Dallas Co to George WILSON for \$650. This was a tract lying in and upon the waters of Mountain Creek and Ten Mile Creek and in the Colony Grant of Peters Colony, known as Section Thirty-one Township two South and Range one West and also held and claimed by a Tax Sale Deed of Benjamin MERRELL, Assessor & Collector of Dallas Co. KEMMEL signed on 11 Oct 1849 in presence of J. M. CROCKETT and J.C.WILSON. Acknowledged 11 Oct 1849 Recorded 31 Oct 1849

p. 201 & 202: Benjamin MERRELL, Dallas Co Assessor & Collector, gave Philip KEMMEL Tax Deed for 640 acres for \$2.80. The lands were of W. D.PETERS & others of The Texas Emigration & Land Co for back taxes in Dallas Co, and were sold at Public Auction, described as follows: Sec 31, Twp 2 S & Range 1 West, sold at Courthouse door. Benjamin MERRELL's signature was witnessed by J. N. BRYAN & Jno. M. CROCKETT. Recorded 31 Oct 1849.

p. 203 & 204: On application by Wm. M. COCHRAN, lot bought from Wm. GRIGSBY and comprising 163 acres and which lot crossed The Traveled Road and National Road, was resurveyed by A. G. WALKER, Dallas Co Surveyor. Resurvey signed 9 Oct 1849 by A. G. WALKER, witnessed by Amos McCOMMAS and Wm. P. CARDEN, C. C. Acknowledged 9 Oct 1849 and Recorded 31 Oct 1849.

p. 204 & 205: By Tax Deed Benjamin MERRILL, Dallas Co Assessor & Collector, sold 1106 acres to Wm. H. SHELTON for \$4,30 for Thomas GATLAN'S 1846 unpaid taxes of \$1.39. This land was known as Survey \$3 on the Trinity River and was sold at the Courthouse door. Deed was signed "Benja MERRELL", witnessed by Jno. M. CROCKETT and J. N. BRYAN 23 Oct 1848 and Recorded 1 Nov. 1849.

p. 206 & 207: On 13 Sept 1845 Anson JONES, President, Republic of Texas, gave Letter of Patent to Westley Carroll WEBB for 320 acres in Robertson Co on Cedar Bluff Creek, a branch of the Trinity River, Surveyed for Joseph PROCTOR, crossing and recrossing Cedar Creek. Signed in the City of Austin by Anson JONES, in presence of Thos Wm WARD, Commissioner. Recorded 15 Nov 1849 by J. W. SMITH, CC. (to be continued)

THE WEYHER GENEALOGY, 1600 - 1981, A FAMILY HISTORY FOR THE CHILDREN OF HARRY FREDERICK WEYHER, JR. AND BARBARA DORE MCCUSKER COVERING THE WEYHER, PARROTT, MCCUSKER, DUBY AND RELATED FAMILIES

Author: Harry F. Weyher, Jr., published 1981. Hardbound. 8 1/2"xll", 422 pp. Order from author, address: 30 East 71st Street, New York, NY 10021. Price not listed.

In this book Weyher has given his fellow Weyher researchers serious genealogical material from fifteen major contributors and from many miscellaneous sources, such as Senator Sam J. Ervin, Jr. Organizing the information in novel manner, the author has produced a "Table of lineal Descent" which begins with his children (the 12th generation) and goes back to some early ancestors (the 1st generation). This is an interesting quasi-introduction to all of the ancestors, but unfortunately, the corresponding ancestor chart is not included in the book. The placement of ancestor #64 is easy, but visualizing ancestor #928 in relationship to the rest of the family is rather difficult.

Weyher is a discriminating author. To his credit: the factual material appears to be unquestionably solid. There is no speculation, guess work, or spongy narrative. References with places, dates and names of contributors abound. Included are many photographs and paintings.

Mentioned in the text are many North Carolina and Virginia families, but their surnames are not listed in the Index. Unfortunately, the Index is a list of the major ancestors, no surnames of the contributors or the surnames of the women who married into the collateral lines. This would be a magnificent genealogical tool if it contained a complete, every-name index. The print is dark, the margins are wide, and the paper is good quality. Other surnames found in this book: Garrett, Tillman, Adams, Hix, Hardy, Kenan, Goodman, and many others.

JAY BIRD NEWS UPDATE. Author: Loretta Jay Davis. Published 1981. Soft bound, 8 1/2"x11", 175 pages. Order from author; address - 4406 Moffett Rd., Ceres, California 95307. Price not listed.

This appears to be a loose leaf news letter which grew into an inch thick manual of material on the Jay family. It

includes queries, ancestor charts, and miscellaneous news items on living members of the Jay families. Some censuses are included. Very impressive is the contribution of Guy S. Perry on the descendants of William and Mary Vestral Jay. There is no index; however, all of the Jay descendants will enjoy reading this from cover to cover.

THE FLOYD BOOK. Author: Mildred Floyd, published 1978. Softbound, 8 1/2"xll", 60 pages. Order from Mrs. J.B. Floyd, 8733 Grovecrest Drive, Dallas TX 75217, \$8.25.

Wils is the story of a Floyd family that migrated from Wilson to North Carolina, Georgia, Alabama, Mississippi and finally, to Texas. In a lengthy introduction the author relates the manner in which she began her research and also the members of the family who supplied her with the initial information. Next, she lists the abbreviations used (note the abbreviation of mother - "Mor" and the use of small case letters in parenthesis). Following is :The Floyd Family Skeleton", which is the cast of the major characters in the book. It lists:

The author begins with a serious discussion of the migration of the many, many Kelso families of several colonies, and then separates the factual information from the numerous traditions that have come through the families. From this point he traces Samuel Kelso/Kelsey (1720 - 1796) of South Carolina and all of his descendants - a monumental task! All facts in this book are substantiated by a source; there are copies of the original bounty grants, complete censuses with concise explanations, and family letters written in 1860 - plus the usual county and state records.

One record, a list of 120 names taken from the account book of Robert Gill, a colonial blacksmith, of Fishing Creek, Chester Dist., S.C. (found on p. 129) is of interest to all researchers with ancestors in Chester Creek.

To finish this work, there is Bonita Kelsey's recipe for Squirrel Stew, and an excellent 50 page Index. This Index appears to be complete and exact. There are almost 700 pages and each has uniform dark printing with even margins. Kelsey/Kelso researchers, how fortunate you are!

The following was contributed by Dorothy ENGLISH, a member of the DOS. The material here was taken from a very small Pastor's Book which is in her possession and which belonged to her grandfather, Samuel L. Crowson. At the time that he used this book, 1914 and 1915 he was serving three Methodist Churches in North Texas, Era, Lois and Spring Creek.

Sister, you have 3 large Aunts down here. Aunt Susan looks like she will weigh about 240. She can beat you some. Her little daughter will now soon be grown. 
