14TH DISTRICT COURT—MINUTE BOOK A ABSTRACTS

Helen Mason Lu & Adrienne B. Jamieson

Dallas County was organized in 1846 and the district court met for the first time Monday December 7th of that year. In these abstracts are to be found the names of the founders of Dallas—as jurors, defendants, and plaintiffs—involved in the usual disputes of life.

The minute books for the 14th District Court dating from its inception Monday, December 7th, 1846 until March 1939 are available in the Texas/Dallas History and Archives Division of the Dallas Public Library in its capacity as a depository for the Regional Historical Resource Depository and Local Records Program (RHRD) of the Texas State Library.

The 14th District Court was the earliest court but the Texas/Dallas Division also holds the records of the other district courts in Dallas County from their founding until 1939. The second court, the 44th District commenced July 1889 and the others were founded in the twentieth century. The extant loose case file papers for the same time period are housed here.

R. C. Crane, Esq. with Mrs. Crane and the baby left last Wednesday night for Eufala, I.T. to participate in a family reunion. This will be the first time the family has been all together at the same time since about 1868. His brother has just returned from the Philippines, and a brother from Houston, sister from Dallas, another brother from Fort Smith and two brothers are in the Indian territory and mother now 73 years old will meet at the home of the brother J. T. Crane who resides at Eufala. As Mr. Crane looks upon this as the last family gathering when all now living will be present, it will be both pleasant and ---. Mr Crane expects to be gone about a week.

A Family Reunion

On Nov. 1st and 2nd there will be a family reunion at the Crane residence which will be quite an event in the history of these people. It has been more than thirty years since so many of this family have been under one roof. Prior to February 1900 there were six men and two women, children of Mrs. Kate J. Crane still living. Since that date Mrs. A. C. Bondies, nee Crane; has passed away. Mrs. Bondies has twice visited her mother at this place.

At this reunion there will be present, Mr. and Mrs. W. C. Crane, of Houston, Texas; Major C. J. Crane, just back from the Philippine islands; G. S. Crane and wife of Checotah, B. D. Crane and wife from Ft. Smith; R. C. Crane and wife of Sweetwater, Texas; and Mrs. J. A. Reppetoe, nee Crane and her son Carey, of Dallas, Texas.

In addition to the above members of the Crane family, there are expected W. C. Bondies and G. B. Bondies and wife of Forney, Texas. These are the grand-children of Mother Crane. There will be with these one great grand-child.

God has been good to these people. The oldest member of the family has stepped into the fifties and the youngest into the thirties. It can hardly be expected that there will ever again be so complete a reunion of this family.

Mr. and Mrs. W. C. Crane returned Tuesday from a memorable visit to Eufala, I.T. where they spent Saturday, Sunday and Monday with the former's mother. Mrs. Crane, Sr. is the widow of the Rev. William Carey Crane, a noted minister of the Baptist communion and the author of a number of books among which "The Life of General Sam Houston" is the most widely known.

On Saturday last, her children and grand-children gathered about her coming from every direction and on every train. This family reunion had been thought of for some time and the arrival of Major Charles J. Crane of the United States Army from the Philippines was the signal for its convocation.

Sunday was the big day when Mrs. Crane had with her, her six sons, the crowning ---- of a beautiful life, loving and devoted to her, and admirable men. What more could a woman ask? Besides the sons were daughters-in-law who have almost as great a love for the gentle mother as her sons, one granddaughter, [the article said "grand-daughter" but it should probably read "daughter"] Mrs. John Reppetoe of Dallas, Texas, many grand-children and one great grandchild.

It was a day to be remembered by all who had a share in the joy of it and will glow as a bright star in the memory of the mother who has done so much for the world in giving to its work six good men. The sons were (taking them according to age) Mr. W. C. Crane of Houston; Major C. J. Crane, United States Army; Mr. Gordon Crane of Checota, I.T.; Mr. R. D. Crane of Fort Smith, Ark.; Mr. T. J. Crane of Eufala, I.T.; and Mr. R. C. Crane of Sweetwater, Texas.

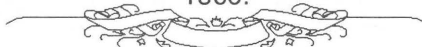

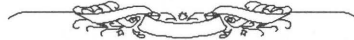
