- TO SUPPORT THE GENEALOGY SECTION OF THE DALLAS PUBLIC LIBRARY.
- TO STIMULATE THE EXCHANGE OF INFORMATION BETWEEN SOCIETY MEMBERS AND GENEALOGICAL RESEARCHERS ACROSS THE NATION.

MEMBERSHIP: The Dallas Genealogical Society is a non-profit, federally tax-exempt organization. Individuals, libraries or societies may apply for membership. Annual dues are \$15.00 for the calendar year if paid by January 31, after January 31 they are \$18.00. [The additional \$3.00 is to defray extra mailing expense.] All current members receive the quarterly journal and the newsletter.

QUARTERLY: The Dallas Quarterly publishes source material and articles of general interest concerning Dallas County and Texas. Manuscripts together with a cover letter giving the Society permission to publish the material should be submitted to the Editor at the DGS mailing address. Non-members should include \$3.00 with each query submitted. To eliminate correspondence and delay we reserve the right to abbreviate or condense. PRESIDENT'S REPORT 1992-93

In 1992-93 my goals were to first serve our membership, second to serve our Dallas Public Library, and third to contribute to the genealogical community as a whole. With the help of a hard working board and the volunteers from our membership, I believe these goals were met. We closed the year with our largest membership on record, a grand total of 936.

Our programs and workshops were well attended and well received. Each served our membership and others interested in furthering their education while bringing in those necessary funds for the Library. The 5th Annual Fall Symposium and Beginner's Workshop was held at Preston Hollow Presbyterian Church on Saturday November 14. This Symposium was an outstanding success with over 700 people in attendance making this the largest autumn event DGS has ever sponsored! Members had requested tapes of the lectures. The organization that tapes all national conferences was at our fall seminar to tape the lectures for resale. The 37th Annual Spring Seminar was held on March 27 with over 500 people at the Richardson Civic Center to hear James L. Hansen of the Wisconsin State Historical Society. The two events together generated over \$15,000. Our publicity was first-rate this year as is indicated by the amount of money earned.

In the Fall our Society adopted new By-Laws. A rewriting was necessary to more efficiently run an organization with a membership as large as DGS. Our By-Laws committee worked long and hard. We appreciate these volunteers who were capable, knowledgeable and committed.

On October 15, 1992, DGS was presented with an Appreciation Award from *THE DALLAS COUNTY HISTORICAL COMMISSION*. The award was presented in recognition of the Society's 37 year history of commitment to genealogy, and preservation of Dallas County records through special projects involving recording, microfilming, abstracting and publishing these records. Special mention was made of the Society's cemetery project. The award plaque is displayed in the Dallas Public Library, 8th Floor Genealogy Section. It is nice to have others recognize the work done by DGS volunteers. Each time a genealogist uses records abstracted by other genealogists, I hope they will think of our dedicated volunteers. It is men and women like this who give back of their time and energy to our field of study.

A new committee was formed to look into DGS long-range planning. These volunteers have been hard at work to raise new funds to help the Dallas Library Genealogy Department increase their space and better serve our members and other genealogists. The endowment fund also became a working project under this committee. Another new committee is the "Focus Group". This group meets each month with staff members of the Dallas Public Library in order to work together to meet needs of genealogists and the Library. Members of DGS are encouraged to make their wishes known to the President concerning needs which might be passed on.

The "1993 Writing Awards" were revamped to encourage more of our members to enter their projects. All entries will be donated to the Dallas Public Library. Winning entries are reviewed in *The Dallas Quarterly*. The "My Most Interesting Ancestor" is printed in the *DGS Newsletter*. Winners were announced at the DGS Annual Spring Seminar. All who entered are to be congratulated on their accomplishment of seeing their research in print! This should be a goal every genealogist strives for.

THE DALLAS QUARTERLY and the *DGS NEWSLETTER* continued to be valuable publications for our members. They are both "first-rate" publications and many genealogists are richer because of these publications. Of course, we all owe a vote of thanks to those who deal with the mailings. Total mailings were 20,627 individual publications. This makes for a great deal of paper to process and take to the Post Office!

We appreciate those who gave special donations to the genealogy collection at the Dallas Public Library. This also takes volunteers to handle our special projects and special committee projects. Handling our finances and writing the minutes of our Board and General meeting are almost like having a full time job. We appreciate the Volunteers who work in this capacity.

The Computer Interest Group continued to grow with informative programs and noticeable growth in attendance. This group took on the responsibility for preparing the labels for all DGS mailings, the tabulation of data collected for the Capital Expansion Project and participation in the nation wide *Civil War Soldiers System Indexing Project* sponsored by the Federation of Genealogical Societies and the National Park Service.

The policy of having Sign-in sheets in the Genealogy Section of the Dallas Public Library was reinstated. This project will help DGS in requesting more funding and space because we have proof of the numbers of people who use the genealogy collection. It is also a help to the Staff of the Genealogy Section in knowing and serving their patrons.

The Summer Lecture Series is a completion of the 1992-93 Board Projects. This summer a fourth session was added. This series continues to be a popular addition to the activities of DGS as well as adding to our funds. The profits from this years series have been earmarked for the Capital Expansion Project.

My thanks and appreciation to the Board, to the volunteers and to the members of DGS for a profitable and educational 1992-93. I hope your needs were met. It was my pleasure to serve such a fine organization as the Dallas Genealogical Society.

14TH DISTRICT COURT—MINUTE BOOK A ABSTRACTS

Helen Mason Lu & Adrienne B. Jamieson

Dallas County was organized in 1846 and the district court met for the first time Monday December 7th of that year. In these abstracts are to be found the names of the founders of Dallas—as jurors, defendants, and plaintiffs—involved in the usual disputes of life.

The minute books for the 14th District Court dating from its inception Monday, December 7th, 1846 until March 1939 are available in the Texas/Dallas History and Archives Division of the Dallas Public Library in its capacity as a depository for the Regional Historical Resource Depository and Local Records Program (RHRD) of the Texas State Library.

The 14th District Court was the earliest court but the Texas/Dallas Division also holds the records of the other district courts in Dallas County from their founding until 1939. The second court, the 44th District commenced July 1889 and the others were founded in the twentieth century. The extant loose case file papers for the same time period are housed here.

Some of the legal phrases used in the abstracts are as follows:

<i>Assumpsit:</i>	A common-law action alleging damage from breach of agreement.
<i>Demurrer:</i>	A pleading that there is some defect which should prevent the case from proceeding.
<i>Mandamus:</i>	A writ issued by a superior court commanding the performance of a specific act or duty.
<i>Nolle prosequi:</i>	An entry on the record that the plaintiff or prosecutor will proceed no further in his action.
<i>Nisi:</i>	Taking effect at a specified time.
<i>Venire:</i>	An entire panel from which a jury is drawn.

These definitions are taken from *Webster Seventh New Collegiate Dictionary*; for a more detailed explanation of the above terms or the meaning of terms omitted consult *Blacks Law Dictionary*.

YELLOW FEVER EPIDEMIC OF 1878

by Helen Mason Lu

Yellow Fever = An acute infectious tropical disease caused by a virus transmitted by the bite of a mosquito and characterized by fever, jaundice, and vomiting, etc.

In the nineteenth century, epidemics of cholera, dysentery and yellow fever were a fact of life, generally starting in port cities or river towns and spreading throughout the south. There were devastating yellow fever epidemics in the late summer and early fall of the years, 1847, 1853, 1867 and 1878. In the March and June issues of the *Dallas Quarterly* many specific deaths from yellow fever were listed in the *Texas Presbyterian* Newspaper Abstracts, but the more general discussion of the epidemic did not fit into the scope of those abstracts. The following abstracts from the same newspaper deal with the widespread effects of the disease on the south.

NAME OF ARTICLE: Notes of the Epidemic

The weekly mortality continues to diminish. The daily reports vary very much, but in the weekly reports there is a noticeable regularity of movement. We have before us the tables of five different epidemics, and we find that this is a characteristic feature of all of them. From the beginning of each epidemic, until it reaches the week of greatest mortality, there is a successive increase in the number of deaths, sometimes larger and sometime smaller, but always an increase. When the climax is reached, there follows a successive decrease; and though the decrease may be irregular, as to the weekly falling off, it is continuous and successive until the epidemic ends. We hardly expect to see the end of this one until the latter part of October.

The week climax has been different in each epidemic. In 1847 it was the week ending September 5. In 1853 it was the week ending August 21. In 1858 it was the week ending September 12. In 1867 it was the week ending September 8. In these years it has varied from August 21 to September--i.e., over a period of five weeks.

Our mortuary reports on September 8th was 548 deaths; on the 15th, 501; and on the week ending September 22d, 408. And although the weather is unfavorable, we suppose it will continue to decrease, in a greater or less ration.

However sad these losses among ourselves, it appears that New Orleans is far less afflicted in proportion to its population than other cities. The Surgeon General at Washington, reports that in the week ending September 12th, the mortality at Memphis, with less than one fourth of our population was more than twice as great as it was in New Orleans for the same period. -S. W. *Presbyterian*, Sept. 26th.

We quote the following mournful table from the *St. Louis Republican*, of the 30th.

Some idea may be formed of the horrors of the situation in the South by a glance at the table found below, showing the extent of the mortality thus far and the area over which the terrible epidemic has spread its black pall. The estimates are of course approximate, as accuracy is impossible, except in a few instances. The figures, however, are rather below than above the facts. The total of over seven thousand is truly appalling, and when we bear in mind the sickness of the thousands who are not represented in the death list, the cost of their idleness, the prostration of commerce, the ruin of crops, the wreck of fortunes, large and small, the utter desolation spread wide over some of the fairest and richest portions of the nation, we may well extend all the sympathy and substantial aid we can spare to our stricken brethren. The number of dead in the several cities and towns to date is about as follows:

If, therefore, the same proportion of cases to deaths is to be observed below as in the above list, then we have a grand total of 41,787 cases, and 10,955 deaths.

This amount will fall short of the exact figures, since no account has been taken of the disease as it occurred in many small towns and cities throughout the South, as well as in the country in very many instances. Several deaths occurred as far north as New York City and as far west as St. Louis, of which no account was taken, while nearly a thousand deaths from malarial fever have been reported in the infested cities in the South, in which there was good reason to doubt the correctness of such diagnosis. We would be within correct bound to estimate the number of cases throughout the country at 50,000 and the number of deaths at 12,000.

There are copies of loose papers found in the Field Family bibles; some seem to be page references to a Field genealogy and those have not been abstracted in this article. However, there are several newspaper articles, some identified and some not that seem to be of interest and these are abstracted below.

Obituary of Henry M. Field; *The World*, Sunday January 27, 1907.

Great Barrington Mass., Jan. 26- Henry Martyn Field, editor for 44 years of the *Evangelist* died early today at his home in Stockbridge. He was the last of the famous Field brothers—Stephen, Cyrus, David, Dudley and Henry Martyn. He was the youngest of ten children of Dr. David Dudley Field, a Stockbridge clergyman. Four became famous: Stephen, 34 years a justice of the United State Supreme Court; David Dudley, construed and codified international law; Cyrus W. Field, laid the first Atlantic cable; Henry, proprietor and editor of the *Evangelist*, a Presbyterian religious newspaper of New York for nearly half a century. Henry was born in Stockbridge April 3, 1822, graduated from Williams College at age sixteen, was pastor of church in St. Louis from 1842–1847. He came to New York and the *Evangelist* in 1860 and also, authored many books.

Obituary of Stephen Dudley Field. Clipping [newspaper not identified.]

"Father of the Trolley Car" dies at age 68 Years.

Stockbridge, Mass.—May 20, [1913]

Stephen Dudley Field, an inventor of international prominence, died at his home Sunday at the age of 68 years. He held more than 200 patents in his name. He was nephew of Cyrus Field, who laid first the Atlantic cable; of David Dudley Field, distinguished jurist; Stephen J. Field, Supreme Court Justice and Henry Field, a noted preacher. His father was Jonathan Edwards Field, a well known lawyer.

The bride a native of Maine has made her hone with her aunt for many years. The groom is a graduate of Worcester Tech as a civil engineer and is employed by the New England Power Co. The father of the groom is a member of the hardware store of Field and Lawrence, Bellow Falls.

Westminster West — The Field Family

In a short article in last week's *Phoenix* on the Field Family there is a slight error in the relationship of Timothy Field to the more celebrated members of the family. He was not the brother of Cyrus or Judge Stephen J. but their uncle. Timothy Field was the brother of Dr. David Dudley Field, long the minister in Stockbridge, Mass., the father of the famous Fields. David D. graduated from Yale in 1804. Timothy Field became minister of the second church in Westminster Jan 1807; retired from the ministry in 1865; died 12 February 1845 at age of 70 and is buried in the church yard.

Two weeks ago some facts were given about this minister of the West Parish Church. Some further information has been found about him—he was born in Madison, Conn. in 1775; graduated from Yale in 1797; and was ordained in Canandaigua, New York, Feb. 27, 1800. He married Wealthy Bishop of Madison, who died with two of her children within a few days in April 1814 of the spotted fever, thought to be what is now known as spinal meningitis.

He married secondly Mrs. Susannah Lusk a native of Northampton. Six children, three by each wife lived to maturity; Alfred B., a merchant of Canandaigua; Mary married to Dr. Orcutt of Northampton; Timothy, who had a college education and lived at Lima, Ind.; Sereno of Skeneateles, NY; Lorenzo of Putney and William of this place. They are now all deceased.

Congregational Church

There was a congregation of nearly 100 to celebrate 100th anniversary of the church, 10 November [1829]. Extracts were read from the sermon preached by Dr. Timothy Field, pastor of the church at the time of the rebuilding of the church after the destruction of the original by fire. Among the congregation were a granddaughter, a grandson, a great-grandson and a great-great-grandson of Timothy Field.

Field married Miss Alzada Mabel MacNeill, daughter of Mrs. Elizabeth A. MacNeill of Worcester in a double ring ceremony performed by the Rev. Harry Minnick of the First Church of Christ, Worcester. Mrs. Green, sister of bride; Baylis G. Aldrich of Douglas, Mass, friend of the groom was best man. Mary A. Chaffee of Worcester, cousin of the bride was bridesmaid. The newly married couple expect to make their home in Worcester.

A paper on the Field family by Roswell Field of Detroit, a son of Eugene Field was read. Some of Field's poems were sung; selections were played on a century old violin that was owned by Gen. Martin Field, famous lawyer and ancestor of the Newfane Field family.

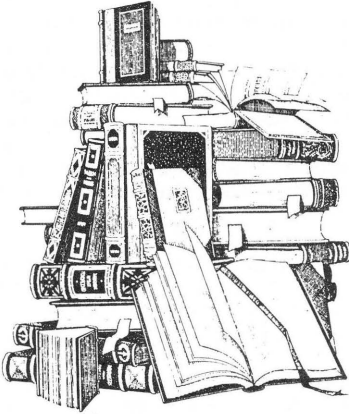

LOGAN COUNTY, KENTUCKY DEED ABSTRACTS, 1792-1813, by Joyce Martin Murray, (1993). Paperback, 8 ½" x 11", v + 176 pages. Three indexes: full name; places & slaves (first-name only). \$30.00 + \$2.48 sales tax for Texas residents + \$3.00 p & h. Order from Joyce Martin Murray, 2921 Daniel, Dallas, Texas 75205.

With this volume, Dallas Genealogical Society member, Joyce Murray, continues her series of deed abstracts from selected counties of Texas, Tennessee and Kentucky. Logan County, Kentucky was created in 1792 from a part of Lincoln County and its' territory encompassed a large portion of southwestern Kentucky. Those with research interests in Simpson, Todd, Butler, Warren, Muhlenberg, Christian, Allen, Hopkins, Barren, Caldwell, Henderson, Livingston and Union should keep in mind that parts of those present-day counties were originally part of Logan.

Deed books may be a genealogist's prime source of documentation, since they relate much more than land transfers, and often contain wills. Here are a few examples from Mrs. Murray's book, proving relationships and giving clues to other places of family residence: "..... Laurence Smith of Warren Co., Ky....for my beloved daughter Elizabeth Smith, now Elizabeth Weller...."; "...Thomas Arnold of Logan Co., but formerly of Greenville Co., S. C....."; "....Walter Jones of Russellville, appoints brother Richard Jones of Montgomery Co., Md....".

HOW TO PUBLISH AND MARKET YOUR FAMILY HISTORY, by Carl Boyer, 3rd. Fourth Edition, 1993. Hardback, 6" x 9", 160 pages. Indexed. \$17.50 (CA residents must add sales tax) + \$2.00 p & h. Order from Carl Boyer, 3rd, P. O. Box 220333, Santa Clarita, California 91322-0333.

The old adage that busy people get more done certainly applies to this author who teaches full time, does research, runs a publishing business, serves on his city council and served a term as mayor! In addition, his publication credits include *Ancestral Lines* and *Ancestral Lines Revised*, four volumes of *Ship Passenger Lists*, and *Slade-Babcock Genealogy*.

This work should be read by beginners before they commence research and by anyone contemplating publication. There are instructions ranging from composition to writing specifications for printing bids. It reviews methods of researching both ancestors and living relatives with a view to building a customer list. The chapter on The Systems Approach to Publication and the graphic Systems Schedule ease the fear of "what to do when".

In 1982, I used my first edition of this book to handle such pesky items as how and when to obtain a copyright and get a Library of Congress catalog number, what goes into a preface and details of dealing with a publisher. In comparing the earlier version with the fourth edition review copy, I found several improvements in an already excellent text. Appropriately, material has been added on computer use, typefaces, word processing, use of macros, etc. But, whether your camera-ready copy is produced with computer technology or with an old manual Smith-Corona, Boyer's book will help you make it the very best, and hopefully profitable, product of your research that it can be.

FISH FAMILIES - RECORDS AND LINES, Volume VI, April 1993, edited by Laurine Mae Palmerton Logsdon. Paperback, stapled, 8 1/2" x 11", 46 pages. Everyname index: part 1, Fish names; part 2, all other surnames. \$6.00 (Washington State residents add \$.60 tax) + \$1.50 P&H. Order from Laurine Logsdon, Lauri-Lines, South 2827 Ivory, Spokane, Washington 99203.

If there are "Fish" in your ancestral waters, this publication could help you catch them. The editor advises that these booklets will be published on an irregular basis, probably 2-3 times yearly. Earlier volumes are still available at the same price, but there is no charge or purchase required to have your queries and records published in this series.

Vol. VI contains sections on marriages (from 5 states); baptisms and births (5 states); wills & administrations (England and 5 states); Bible Records, military records, family groups and queries. Sources are cited for each record - most are from books; some from National Archives and LDS microfilm.

The editor shared a helpful suggestion for tracking down someone from an old query when you get a "forward time expired" message: write one or more letters to "occupant" at a nearby address asking if they know where their former neighbor lives now. It's worth a try.

THE GREAT WEST, or the Garden of the World; Its History, Its Wealth, Its Natural Advantages, and Its Future. Also Comprising a Complete Guide to Emigrants, with a Full Description of the Different Routes Westward. With Statistics and Facts, from Hon. Thomas H. Benton, Gen. Sam Houston, and Col. John C. Fremont, by C. W. Dana. 1859, reprinted 1993. Paperback, 5 ½" x 8 ½", v + 399 pages, index. \$16.50 (plus sales tax for Maryland residents), + \$3.00 P&H. Order from Heritage Books, Inc., 1540-E Pointer Ridge Place, Suite 300, Bowie, Maryland 20716.

"The Great West" lured many of our ancestors, judging by their steady movements in that direction. Some may have even used this book as a guide, as it was written in 1859 to stimulate emigration. Chapters on Ohio, Indiana, Illinois, Michigan, Wisconsin, Iowa, Missouri, Kansas, Nebraska, Minnesota, Texas, New Mexico, Utah, Oregon, Washington Territory and California describe history, boundaries, settlements, climate, agriculture, improvements, education, etc. Railroad tables and other information on distances helped prepare the traveler for his trip.

Potential users of this book may be misled by the title's, "with a Full Description of the Different Routes Westward" as it does not contain maps or the type of migration-route info that today's genealogists might expect.

A letter from Sam Houston to a Mr. Murphy, American minister to the Texan government, advocating annexation by the United States, (which took place in 1845), fills eight pages of the chapter on Texas.

WHISNANTS THROUGH THE AGES, compiled and edited by Raymond C. Whisnant, 6646 Clearhaven Circle, Dallas, Texas 75248. Hardback, 8 ½" x 11", x + 524 pages. Illustrated, full name index.

The book treats twelve generations descending from Francois "Franz" Visinant, born ca 1646 in Maracon, Lausanne, in the Swiss nation of Vaud, a French speaking area of Switzerland. The first of this line in the colonies arrived at Philadelphia in 1731. Spelling variations of Whisenand, Whisenhunt, etc. are found in records.

MASON PLUMMER HAYES — ERVENA ROSELLA RUST, WHEN DALLAS WAS GROWING UP, by Terence G. Walsh, 6924 Kenworthy Drive, Dallas, Texas 75231. Unbound, vi + 113 pages in folder. Illustrated, full-name index, plus indexes to businesses, places and other.

This is a warm, personal account of the author's grandparents based primarily on family records and information, supplemented with public records research. Both grandparents arrived in Dallas as children in the mid-1870s and lived here the rest of their lives. The pages are rich with anecdotes of family and of a growing city.

THE HILLGERS — FROM GERMANY TO TEXAS, by Jim Monaghan, 11227 Dumbarton Drive, Dallas, Texas 75228. Hardback, 8 ½" x 11", x + 373 pages. Illustrated, full-name index.

This work includes all known descendants of Louis Henry and Jane (Phillips) Hillger and those of Jim Gustave and Minnie (Scheide) Hillger, two of the six children of (name unknown) Hillger and wife, Juliane. The family emigrated from Prussia ca 1864.

References in the first four generations are footnoted and statements not based on primary evidence are clearly marked, "opinion", "conjecture" or "conclusion". A section of descendants' charts helps the reader follow the family lines.
