14TH DISTRICT COURT—MINUTE BOOK A ABSTRACTS

Dallas County was organized in 1846 and the district court met for the first time Monday December 7th of that year. In these abstracts are to be found the names of the founders of Dallas—as jurors, defendants, and plaintiffs—involved in the usual disputes of life.

The minute books for the 14th District Court dating from its inception Monday, December 7th, 1846 until March 1939 are available in the Texas/ Dallas History and Archives Division of the Dallas Public Library in its capacity as a depository for the Regional Historical Resource Depository and Local Records Program (RHRD) of the Texas State Library.

The 14th District Court was the earliest court but the Texas/Dallas Division also holds the records of the other district courts in Dallas County from their founding until 1939. The second court, the 44th District commenced July 1889 and the others were founded in the twentieth century. The extant loose case file papers for the same time period are housed here.

TEXAS CONFEDERATE PENSIONS

The Genealogy Section of the Dallas Public Library has acquired the first 86 rolls of microfilm of *Texas CSA Approved Pension Applications* which comprises Applications #1 through #11831. There are 700 rolls in the entire set which also includes the rejected pensions; at present the first 86 rolls are available and another 117 rolls are on order; the remaining rolls will be ordered as the budget allows. *Editorial Note: Donations would help to purchase this important Texas resource.*

The original records are at the Texas State Library, Austin and were filmed in 1974 by the Genealogical Society, Salt Lake City, Utah. The applications are filmed in numerical order and are indexed in:

Index to Texas CSA Pension Files, Virgil D. White 1989

 Index to Applications for Texas Confederate Pensions, John M. Kinney 1977. [Dallas Public Library call number 973.7 K551]

Each application consists of an Application Form #1 for Soldier or Sailor or Form #2 for widow of Soldier or Sailor plus affidavits and depositions from persons attesting to the veterans service, indigence, etc. Some include miscellaneous letters pertaining to the application.

As space permits, abstracts of the Dallas County approved pensions will be included in continuing issues of the *DGS Quarterly*. The series began in Volume XL, Number 2, June 1994. The questions asked on the soldier's or sailor's application are listed below. Immediately following is a listing of the questions asked on the widow's application. If the abstract does not reference a particular question, the answer was in the negative.

BOOK REVIEWS

The four manuscripts reviewed below were entries in the Dallas Genealogical Society's 1994 Writing Awards Competition, which is an annual event, open to all society members. The copies have been placed in the Genealogy Section of the J. Erik Jonsson Central Library.



GRANDMAMIE'S FAMILY, A pictorial history and stories of the Clark, Foreman, Jackson, Pollock, Tabb, Weast, Wehring, Wilson and Wood family group in Texas, compiled by Ruth Foreman Slatton, 7011 Casa Loma Ave., Dallas, Texas 75214. 3-ring notebook, 316 pages plus full name index.

This winning entry in the manuscript category centers around the ancestors of Mamie Wilson Clark, Clem Wesley Tabb and Jeff Weast Wood, Sr. and tracks migrations from the northeast to Mississippi, Louisiana and Texas. The abundance of snapshots, studio portraits, newspaper clippings and family stories gives one the feeling of looking through this family's photo albums and scrapbooks. For genealogists, there are ancestor and descendant charts. The chapters are chronological from the Revolutionary War to the present. A unique feature of each chapter is that historical headlines are interspersed with the birth/marriage/death/migration, etc. statistics and memoirs, giving the reader a sense of the history experienced by the individuals living in that period.

The compiler admonishes that her work reflects only one year's research and should not be relied on as a genealogical reference, but rather is intended to preserve the pictorial and oral history of the family.

The Descendants of John Wesley Foster and His Wife, Martha Frances Jones Foster, by Jean Foster Kelley, 3416 Wolfe Circle, Plano, Texas 75025-2226. 58 legal size pages, including full name index.

John Wesley Foster and Martha Frances Jones were married 14 June 1855 in Sullivan County, Missouri. This couple had eleven children, but only four had descendants. This manuscript is a record of the descendants of those four. The bulk of the text is descendant charts augmented by family information, and some data from published sources, military and census

records. The very nice print quality gives the material a professional look.

Matrilineal Primogeniture by Mary Reid Warner, 6110 Misty Trail, Dallas, Texas 75248.

This fourteen page manuscript explores the first born daughter descendants of Leah J. Whitson and Ignatious Raines. This uncommon approach to lineage research illustrates the difficulty of tracing maternal lines, made even more difficult by the fact that it intails southern lines where records are often not as available as other areas of the country.

Extensive endnotes and a full name index supplement this paper on nine generations of a female line.

* * * *

The First Family Hughes of Shelby County, Texas by Len B. Hughes, B.S., M.D. The author states that aside from personal satisfaction, his goal was to "provide the written historical foundation for subsequent generations to build upon the legacy provided by their ancestors...." He arranged the material in somewhat of a chronological order with some geographical divisions. Ennis Hughes was born about 1790, probably in North Carolina. The earliest documentation found on this ancestor was his enlistment in Warren County, Tennessee for service in the War of 1812. In 1814 he married Mary McCain in Warren County. The family moved to Alabama and later to Arkansas where Ennis died in 1833. In 1839 the widow and children arrived in Shelby County, Republic of Texas.

The manuscript's 18 chapters explore this family through records of the places they lived and military records. A lengthy bibliography, pictures, maps and historical background data enhance this work.

The Kay Chronicles (1992) published by the Kay Family Association, 26 Paisley Park, Sumter, South Carolina 29150. Hardback, 8 1/2" x 11", 333 pages. Illustrated, full-name index.

The Chronicles of the Family of Kay of Lancashire from the XIVth to the XXth Century was compiled in 1909 by Englishman Kenneth Kay but was

never published. A descendant gave the Kay Family Association permission to publish the rare manuscript which begins in the year 1332 with the earliest known records of the Kay surname and traces the various branches of the family to the end of the nineteenth century.

Frank Spearman of South Carolina added a section which ties the Kay family of early Virginia to its Lancashire roots. James and William Kay arrived in the Colony of Virginia approximately 1658 and James "Key" served as a juror in Gloucester County in 1665.

Two previous books on the Kay family have been donated to the genealogy section of Dallas' J. Erik Jonsson Library: The Descendants of Robert Kay of South Carolina, compiled by James E. Kay, William D. Kay, Jeremiah A. Kay and Franklin A. Spearmar and The Ancestors of Robert Kay of South Carolina by Carl B. Kay and Lynn M. Kay which traces the several generations in Virginia descending from the original English immigrant, James Kay, to Robert Kay.

Gone to Texas: Genealogical Abstracts from *The Telegraph and Texas Register* 1835 1841 compiles by Kevin Ladd. 332 pp., indexes, paper, \$25.00. Order from Heritage Books, Inc., 1540-E Pointer Ridge Pl., Suite #300, Bowie, MD 20716. Shipping is \$3.50 and Visa, MasterCard, Checks, and Money Orders are accepted.

This book is aimed at genealogists with Texas roots, genealogists in search of missing ancestors, and also readers interested in Texas local history. The *Telegraph and Texas Register* was born at the time of the Texas Revolution, chronicling the momentous events of that conflict for its

Texian subscribers. In the days of the new Republic of Texas, it emerged as the Texian national newspaper. Its pages were filled with news of murders, fatal encounters with Indians and Mexicans, unusual deaths, marriages, probate proceedings, and ordinary events of the new Republic. The gleanings of genealogical information document thousands of events that can often be found nowhere else. This information will provide family and local historians with important source material. It will also assist researchers who have been hampered by the loss and destruction of county records, as well as the absence of 1830 and 1840 Texas censuses. Finally, this volume helps to document elusive folks who sought to avoid either creditors or the law by going to Texas.

The index has 10,000 references to individuals and a place name index with references to hundreds of towns, cities, counties, forts and frontier settlements. The book also includes a separate index to slave names.
