MEMBERSHIP: The Dallas Genealogical Society is a non-profit, federally tax-exempt organization. Individuals, libraries or societies may apply for membership. Annual dues are \$15.00 for the calendar year if paid by January 31, after January 31 they are \$18.00. 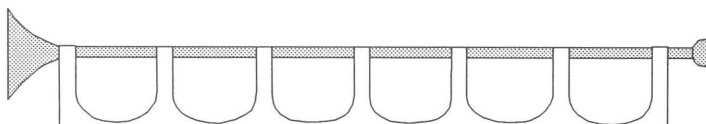

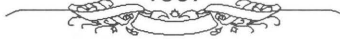

14TH DISTRICT COURT—MINUTE BOOK A ABSTRACTS

Helen Mason Lu & Adrienne B. Jamieson

Dallas County was organized in 1846 and the district court met for the first time Monday December 7th of that year. In these abstracts are to be found the names of the founders of Dallas—as jurors, defendants, and plaintiffs—involved in the usual disputes of life.

The minute books for the 14th District Court dating from its inception Monday, December 7th, 1846 until March 1939 are available in the Texas/Dallas History and Archives Division of the Dallas Public Library in its capacity as a depository for the Regional Historical Resource Depository and Local Records Program (RHRD) of the Texas State Library.

The 14th District Court was the earliest court but the Texas/Dallas Division also holds the records of the other district courts in Dallas County from their founding until 1939. The second court, the 44th District commenced July 1889 and the others were founded in the twentieth century. The extant loose case file papers for the same time period are housed here.

Some of the legal phrases used in the abstracts are as follows:

<i>Alias capias:</i>	A legal writ commanding the officer to arrest the person named it.
<i>Autrefois convict:</i>	A plea by a criminal in bar to an indictment that he has been formerly convicted of the same crime.
<i>Certiorari:</i>	A writ of a superior court to call up the records of an inferior court.
<i>Ex officio:</i>	By virtue of or because of an office.

These definitions are taken from *Webster's Seventh New Collegiate Dictionary* or from *Black's Law Dictionary*.

CORONER'S REPORTS

by Gerri Brannan

An inquest is held to determine cause of death in cases of violent, sudden or unexplained death or if the deceased has not been recently under a physician's care. The findings of the inquest are recorded in Inquest Dockets or Coroner's Reports. These records for Dallas County are available for the years 1897 through 1969 in the Texas/Dallas History and Archives Division of the Dallas Public Library in its capacity as a depository for the Regional Historical Resource Depository and Local Records program (RHRD) of the Texas State Library.

These records variously labeled, *Coroner's Minutes* or *Inquest Docket Books* are in ledger type volumes with an index at the front and the cases following in chronological order. Each record is on a double page with space on the left page for the following information:

Name and description of the deceased; Date of death if known; Where died, or where body was found; Date of inquest; Where inquest was held; Nature of information and by whom given; Name of suspected person; Principal or accomplice; Residence of suspected person; Date of arrest; Where confined; Date of Bail Bond; Residence of person(s) on bail; Names and addresses of sureties on bail bond. [Note: Generally only a few of the spaces are completed.]

On the right hand page are entered the findings of the coroner as to cause of death with his sworn statement.

Mrs. H. J. Irvine, a white woman of 69 years died 26 January 1898 from Bright's disease and old age. Page 262.

May Arbuckle, a colored child aged 8 months, died 29 January 1898 from inertia and inattention. Page 263.

H. H. Hooper, a colored man, died 5 February 1898 poisoned by his own hand with suicidal intent. Page 264.

Unknown white infant died in February 1898; child was found in Trinity River near Oak Cliff Bridge; cause of death is unknown. Page 265.

Hettie Moore, a colored woman died January or February 1898. Her body was found in the Trinity River 5 miles north of Dallas. The cause of death were blows to the head presumably inflicted by Jim Moore, her husband. Page 266.

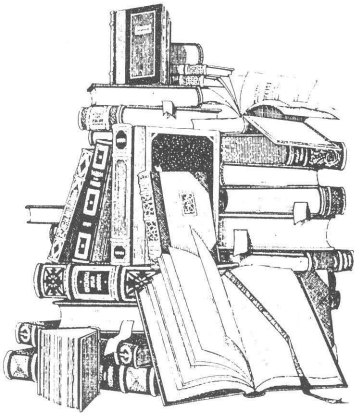
Mrs. George B. Clark, a white woman, came to her death on 9 March 1898 from a pistol shot wound in left breast inflicted by herself with suicidal intent. Page 269. Mrs. Clark, professionally known as Louise Lancaster, left the following note:

Dear Boyd,

I have born all I can in this world and can bear no more. I am going, dearest, to set you free—free to be happy. I love you now when it is too late, oh so dearly. Save my name all you can for Mamie's sake if not for my own. I cannot write to her but tell her that her mama loved her better than all the world and she died with her name on her lips, yours and hers, dear, my two loved ones. Tell her to always be good and true and always remember with love and pity, her loving mother. Give her all I have except whatever trinket you wish to keep of mine. Get the rings for her, also, write to A. H. Fanshawe, through the *Clipper* and demand the diamond marquis ring he has of mine. Give that to her, also. Boyd, won't you always try to help her a little, you and Frank. And the insurance you have in my name put in hers even if you do marry again. Pay off my debts before you marry. Also, \$50.00 to S. McElroy, the \$15.00 on my rings and \$7.50 to the Hotel Windsor, Dallas, Texas and also piano. And now my dearest, goodbye forever to you and my darling child, my dear sisters, brother and friends, good bye and God bless you one and all and keep you safe. Happy is the dying of her who was once your love, Wife Stella. Forgive me and pardon me, I enclose the \$5.00 you sent me.

BOOK REVIEWS

DALLAS JEWISH GENEALOGICAL GUIDE - RESOURCES FOR DOING JEWISH GENEALOGY DISTANT FROM MAJOR RESEARCH CENTERS, by David A. Chapin, (1993). Paperback, 8 ½" x 11", viii + 134 pages. \$18.00 + \$2.50 postage and handling. No sales tax charges for any state. The book is a fundraiser for the Dallas Jewish Historical Society and may be ordered from the Society, 7900 Northaven Road, Dallas, Texas 75230.

The purpose of this guide is to provide a source book for new Jewish genealogists who do their work based in the Dallas, Texas area, or any location far from the larger cities on either coast. It is geared primarily toward those Jews whose ancestors came from Eastern Europe and the former Soviet Union.

The book is written in a readable, rather informal, style and is designed to serve as both a textbook for a course in Jewish genealogy and as a reference source book. Bibliographical references are handily placed with the topic under discussion and include complete ordering information and, in some instances, a library's Dewey Decimal System numbers.

This book is arranged in somewhat the same order as one would do his research. The eight sections are: How to Begin (includes oral history, record keeping, etc.); Computers and Genealogy; U. S. Public Records; Mormon Records; Jewish Names (including reading Hebrew on tombstones); Back to the Old Country (includes key Judaic Resource Centers, Holocaust research, Russian and Soviet Union sources); Jewish Genealogical Resources in the Dallas Area; and What To Do Next When You Run Out of Steam. Appendices include foreign language alphabets, map of the Pale of Settlement and soundex systems (including the familiar U. S. census system and the Daitch-Mokotoff system which addresses the special considerations of Slavic and other Eastern European names.)

A reviewer is privileged to have the opportunity to examine books that may not be relevant to his or her own personal genealogical quests, but are nonetheless fascinating and enlightening. Such is the case in this instance as I encountered new words, concepts and sources.

I learned that Yizkor books are memorial books written to recall the Jewish life in towns and shtetls of Eastern Europe. (Shtetls were explained to me as towns in which only Jewish people lived.) The memorial books can provide valuable information about the Jewish institutions in the shtetl, some key personalities, and sometimes maps and photographs. Most are written in Hebrew, but a few are in Yiddish or English. The majority of the more than 700 published are about towns outside the former Soviet Union. They are still being written today as the newly-arrived Russian-Jewish immigrants are anxious to tell the world about the horrors of the Holocaust. The Perry Castaneda Library of the University of Texas at Austin is mentioned as having an extensive collection of Yizkor books, but the largest collections are found outside of Texas.
